 2 An act relating to a review under the Open Government
 3 Sunset Review Act; amending s. 627.352, F.S., which
 4 provides an exemption from public record and public
 5 meeting requirements for certain data and information
 6 relating to cybersecurity; repealing exemption
 7 relating to data and information from technology
 8 systems; making technical changes; requiring specified
 9 information be made available to certain entities;
 10 removing the scheduled repeal of the exemption;
 11 providing an effective date.

15 Section 1. Section 627.352, Florida Statutes, is amended
 16 to read:

56 (2) Those portions of a public meeting as specified in s.
 57 286.011 which would reveal data and information described in
 58 subsection (1) are exempt from s. 286.011 and s. 24(b), Art. I
 59 of the State Constitution. No exempt portion of an exempt
 60 meeting may be off the record. All exempt portions of such a
 61 meeting must be recorded and transcribed. The recording and
 62 transcript of the meeting must remain confidential and exempt
 63 from disclosure under s. 119.07(1) and s. 24(a), Art. I of the
 64 State Constitution unless a court of competent jurisdiction,
 65 following an in camera review, determines that the meeting was
 66 not restricted to the discussion of data and information made
 67 confidential and exempt by this section. In the event of such a
 68 judicial determination, only that portion of the transcript
 69 which reveals nonexempt data and information may be disclosed to
 70 a third party.

71 (3) The confidential and exempt records and portions of
 72 public meeting recordings and transcripts ~~described in~~
 73 ~~subsection (2)~~ must be available to the Auditor General, the
 74 Cybercrime Office of the Department of Law Enforcement, and the
 75 Office of Insurance Regulation. Such records and portions of

76 | public meetings~~s~~, recordings~~r~~, and transcripts may be made
 77 | available to a state or federal agency for security purposes or
 78 | in furtherance of the agency's official duties.

79 | (4) The exemptions provided by this section apply to
 80 | records held by the corporation before, on, or after March 21,
 81 | 2018 ~~the effective date of this act.~~

82 | ~~(5) This section is subject to the Open Government Sunset~~
 83 | ~~Review Act in accordance with s. 119.15 and shall stand repealed~~
 84 | ~~on October 2, 2023, unless reviewed and saved from repeal~~
