**Economic Self-sufficiency;** Provides requirements for local workforce development boards; requires DOC to develop certain training; authorizes participation in programs or courses for specified number of hours per week; authorizes DOC to suspend work requirements; requires DCF to administer exit survey; provides requirements for voluntary case management services; requires development of intake & exit surveys & survey results to be disseminated quarterly; creates School Readiness Subsidy Program within DOE; provides requirements for such program. Effective Date: July 1, 2024

Children, Families & Seniors Subcommittee: Favorable With Committee Substitute; Appropriations Committee: Favorable With Committee Substitute; Health & Human Services Committee: Favorable

**CS/HB 855** by Health & Human Services Committee, McClure, Berfield (Similar SB 302)

**Dental Services;** Requires dentists & certain partnerships, or corporations to designate with board dentist of record & provide information to certain patients; requires any individual, partnership, or corporation that provides dental services through telehealth to make available specified information; defines term "advertisement"; requires advertisements of dental services provided through telehealth to include specified disclaimer; provides requirements for initial examination for orthodontic appliances; defines "in-person examination." Effective Date: July 1, 2024

**HIV Infection Prevention Drugs;** Authorizes licensed pharmacists to screen for HIV exposure & order & dispense HIV infection prevention drugs in accordance with written supervisory protocol; requires Board of Pharmacy, in consultation with Board of Medicine & Board of Osteopathic Medicine, to adopt rules. Effective Date: July 1, 2024

**CS/HB 1501** by Health Care Appropriations Subcommittee, Gonzalez Pittman (Similar SB 7018)

**Health Care Innovation;** Creates Health Care Innovation Council within DOH for specified purpose; requires council to submit annual reports to Governor & Legislature; requires department to administer revolving loan program for applicants seeking to implement certain health care innovations in this state; authorizes department to contract with third party to administer program, including loan servicing, & manage revolving loan fund. Effective Date: upon becoming a law

**SB 7018** by Health Policy, Harrell (Similar CS/HB 1501)

**Health Care Innovation;** Creating the Health Care Innovation Council within the Department of Health for a specified purpose; requiring the council to submit annual reports to the Governor and the Legislature; requiring the department to administer a revolving loan program for applicants seeking to implement certain health care innovations in this state; authorizing the department to contract with a third party to administer the program, including loan servicing, and manage the revolving loan fund, etc. Effective Date: Upon becoming a law

Effective Date: upon becoming a law

**Health Care;** Revising the purpose of the Dental Student Loan Repayment Program; requiring the Department of Health to implement the Dr. and Mrs. Alfonse and Kathleen Cinotti Health Care Screening and Services Grant Program for a specified purpose; providing requirements for birth centers designated as advanced birth centers with respect to operating procedures, staffing, and equipment; requiring advanced birth centers to enter into a written agreement with a blood bank for emergency blood bank services; authorizing certain psychiatric nurses to order emergency treatment of certain patients; creating the Training, Education, and Clinicals in Health (TEACH) Funding Program for a specified purpose; enacting the Interstate Medical Licensure Compact in this state, etc. Effective Date: Except as otherwise expressly provided in this act, this act shall take effect upon becoming a law

Effective Date: on the same date that HB 1549 or similar legislation takes effect

**SB 322 by Burton** (Similar CS/HB 7041, Compare CS/CS/HB 1549, SB 1500)

**Public Records and Meetings;** Providing an exemption from public records requirements for certain information held by the Department of Health, the Board of Medicine, the Board of Osteopathic Medicine, the Board of Speech-Language Pathology and Audiology, and the Board of Physical Therapy Practice pursuant to the Interstate Medical Licensure Compact, the Audiology and Speech-Language Pathology Interstate Compact, and the Physical Therapy Licensure Compact, as applicable; authorizing disclosure of the information under certain circumstances; providing an exemption from public meetings requirements for certain meetings, or portions of meetings, of the Interstate Medical Licensure Compact Commission, the Audiology and Speech-Language Pathology Interstate Compact Commission, and the Physical Therapy Compact Commission; providing for future legislative review and repeal of the exemptions; providing statements of public necessity, etc. Effective Date: On the same date that SB 7016 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

**Homeowners' Associations;** Revises provisions relating to homeowners' associations including standards & education for officers, directors, managers, or management firms of HOA; official records; debit card use; detailed accountings & audited financial statements; the provision of HOA's rules & covenants to members; fines and suspensions; attorney fees and costs; priority of payments; liens; appeals of certain decisions; prohibited clauses in association documents; assessments; & criminal penalties. Effective Date: July 1, 2024

**Department of Business and Professional Regulation;** Requires persons or entities licensed by DBPR's Division of Alcoholic Beverages & Tobacco to create & maintain account with division's online system; requires persons or entities certified or registered under Elevator Safety Act to create & maintain online account with DBPR; requires applicants for accountancy licensure examination to create & maintain online account with DBPR; requires persons seeking licensure as Florida CPA to create & maintain online account with DBPR; requires persons or entities licensed or permitted by Division of Alcoholic Beverages & Tobacco to create & maintain account with division's online system. Effective Date: July 1, 2024

**School Safety;** Revises provisions & establishes reporting requirements for school guardian programs & school guardians; revises school safety requirements for DOE, school districts, charter schools, & school safety specialists. Effective Date: July 1, 2024

Judiciary Committee: Favorable With Committee Substitute; Appropriations Committee: Favorable; Education & Employment Committee: Favorable With Committee Substitute

**HB 1109 by Fine, Lopez, V., Maney** (Identical SB 1396)

**Security for Jewish Day Schools and Preschools;** Requiring DOE to establish program to provide funds to Jewish day schools & preschools for specified security purposes; provides authorized uses for such funds. Effective Date: July 1, 2024

Judiciary Committee: Favorable; Appropriations Committee: Favorable; Education & Employment Committee: Favorable

**HB 931 by McClain, Daniels, Bankson, Dunkley, Fine, Melo** (Similar CS/SB 1044)

**School Chaplains;** Authorizes school districts & charter schools to adopt policy to allow volunteer school chaplains; requires district school boards & charter school governing boards to assign specified duties to such volunteer school chaplains; requires volunteer school chaplains to meet certain background screening requirements; requires each district school board & charter school to vote by specified date on adoption of school chaplain policy. Effective Date: July 1, 2024

**CS/HB 1317 by Choice & Innovation Subcommittee, Duggan** (Similar CS/SB 1016)

**Patriotic Organizations;** Authorizes school districts to allow representatives of patriotic organizations certain opportunities to speak to students, distribute certain materials, & provide certain displays relating to patriotic organizations; requires certain school districts to provide date & time for such patriotic organizations to speak with students, distribute materials, & provide certain displays; authorizes patriotic organizations to be provided certain access to school buildings & properties. Effective Date: July 1, 2024

**CS/HB 1429 by Education Quality Subcommittee, Bell, Valdés** (Similar SB 1652)

**District and School Advisory Councils;** Renaming "district advisory councils" & "school advisory councils" as "district community advisory boards" & "community advisory boards"; & revises requirements for such boards. Effective Date: July 1, 2024

Education Quality Subcommittee: Favorable With Committee Substitute; Education & Employment Committee: Favorable

**CS/CS/HB 403 by Infrastructure Strategies Committee, Transportation & Modals Subcommittee, Chaney, Bankson, Caruso, Mooney, Skidmore, Yarkosky** (Compare HB 105, CS/HB 121, HB 407, HB 645, HB 733, CS/HB 911, CS/HB 1671, CS/SB 60, SB 244, CS/SB 434, SB 512, CS/SB 858, CS/CS/SB 934, SB 982)

**Specialty License Plates;** Exempts collegiate license plates from certain discontinuation & presale voucher requirements for specialty license plates; requires DHSMV to reauthorize previously discontinued collegiate license plates; renames & revises words appearing on certain plates; directs DHSMV to develop specified plates; provides for distribution & use of fees collected from sale of plates. Effective Date: October 1, 2024

Transportation & Modals Subcommittee: Favorable With Committee Substitute; Infrastructure Strategies Committee: Favorable With Committee Substitute

---

**CS/CS/HB 981 by Infrastructure Strategies Committee, Transportation & Modals Subcommittee, Bankson** (Compare CS/CS/SB 1362)

**Aviation;** Requires owner or lessee of proposed vertiport to comply with specified requirements; requires DOT to conduct specified inspection of vertiport; provides duties of DOT with respect to vertiports, advanced air mobility, & other advances in aviation technology; requires report to Governor & Legislature; requires airports to competitively bid vertiport operator contracts; revises requirements for adoption of airport land use compatibility zoning regulations. Effective Date: July 1, 2024

Transportation & Modals Subcommittee: Favorable With Committee Substitute; Infrastructure & Tourism Appropriations Subcommittee: Favorable; Infrastructure Strategies Committee: Favorable With Committee Substitute

---

**CS/CS/HB 1113 by Infrastructure Strategies Committee, Transportation & Modals Subcommittee, Killebrew, Barnaby** (Similar CS/SB 1164)

**Use of Lights and Sirens on Emergency Vehicles;** Authorizes driver of authorized emergency vehicle to exercise certain privileges when transporting organs or surgical teams for organ donation or transplant to certain locations; authorizes authorized emergency vehicles to operate emergency lights & sirens in emergency; authorizes organ transport vehicles to show or display red lights; authorizes organ transport vehicle to display or use red warning signals. Effective Date: July 1, 2024

**HB 471 by Fine** (Identical SB 886)

**Valuation of Timeshare Units;** Specifies methodology by which certain timeshare units must be valued in certain tax appeals; provides that methodology meets constitutional mandate for just valuation. Effective Date: July 1, 2024

Ways & Means Committee: Favorable; Commerce Committee: Favorable

**CS/HB 481 by Civil Justice Subcommittee, Maggard** (Similar CS/SB 612)

**Building Construction Regulations and System Warranties;** Provides specified effective date for provisions relating to HVAC manufacturer's warranty transfers; prohibits HVAC manufacturer's warranties from being conditioned upon product registration; provides effective date for certain HVAC systems & components warranties under specified circumstance; provides required information for warranty & product registration cards & forms; prohibits HVAC systems & components warranties from being conditioned upon product registration. Effective Date: July 1, 2024

---

**HB 353 by Maney** (Identical SB 570)

**Alternative Headquarters for District Court Judges;** Authorizes district court judges to have appropriate facility in adjacent county to their county of residence as their official headquarters; authorizes subsistence & travel reimbursement for such locations. Effective Date: July 1, 2024

Civil Justice Subcommittee: Favorable; Justice Appropriations Subcommittee: Favorable; Judiciary Committee: Favorable

---

**HB 521 by Koster** (Identical SB 534)

**Equitable Distribution of Marital Assets and Liabilities;** Requires court to consider certain factors when determining if extraordinary circumstances exist; provides certain actions do not change whether real property is marital property; provides that business interests in closely held business is marital asset; requires court to consider certain factors when determining value of such interest; provides that certain real property is nonmarital asset. Effective Date: July 1, 2024

---

**CS/HB 347 by Judiciary Committee, Truenow** (Similar SB 1252)

**Exemptions from Products Liability Actions;** Specifies circumstances under which products liability actions may not be brought against agricultural employers, distributors, dealers, or applicators. Effective Date: July 1, 2024

Civil Justice Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

---

**CS/CS/HB 619 by Transportation & Modals Subcommittee, Civil Justice Subcommittee, Tuck** (Identical CS/SB 1534)

**Sovereign Immunity for Professional Firms;** Provides applicability; requires that contracts with certain professional firms must, to extent permitted by law, provide indemnity to DOT. Effective Date: July 1, 2024

**CS/HB 801 by Criminal Justice Subcommittee, Buchanan, Bartleman, Basabe, Franklin, Garcia, Tant** (Similar CS/CS/SB 208)

**Alzheimer's Disease and Related Dementia Training for Law Enforcement Officers;** Requires FDLE to establish online, continued employment training component relating to Alzheimer's disease & related forms of dementia; requires training component be developed with DOEA; specifies instruction requirements for training; authorizes completion of such training to count toward certain requirement. Effective Date: October 1, 2024

**B. PROCEDURES:**

Time allocations apply to all bills listed in Section A and any bill substituted for or taken up in lieu of a listed bill. Amendment sponsors shall have 2 minutes to open and 2 minutes to close, except as outlined below.

Except for the bills listed in Section C, the House shall spend no more than the following times:

- For each bill:
  - Questions and answers - 10 minutes
  - Debate - 5 minutes
- For each amendment:
  - Questions and answers - 5 minutes
  - Debate - 5 minutes

For all bills, along with their associated amendments, the time for questions and answers includes both the question and the answer and shall be no more than the times listed. Neither the question nor the answer shall be protracted in an attempt to use up the time.

Once more than 10 non-bill sponsor amendments are filed, the allocation of time spent on each non-bill sponsor amendment shall be determined as follows:

- 90 minutes divided by the total number of non-sponsor amendments filed.
- The time allocated for each non-bill sponsor amendment shall be divided equally between the open, questions, debate, and close.
- Amendments withdrawn prior to consideration of the bill don't count toward the total.

For the bills listed in Section C, time spent on debate shall be allocated as specified, with the time equally divided. In addition to the allotted time, the sponsor will explain and close the bill, closing not to exceed 10 minutes. After opening, the debate managers identified below (or their designee) shall be alternately recognized until their time runs out. Time not utilized is lost.

- Debate managers may speak in debate and yield time to other Members to debate; no Member may be recognized for debate unless a debate manager yields time to that Member. Recognitions of debate managers must go through the Speaker. A Member may not be recognized more than once in debate on the bill or amendment.
