### FOURTH EXTENSION OF AGREEMENT FOR STATE LOBBYING SERVICES

THIS FOURTH EXTENSION OF AGREEMENT FOR STATE LOBBYING SERVICES made and entered into on 07 February 2024 by and between the CITY OF SARASOTA, FLORIDA, a municipal corporation, hereinafter referred to as "CITY," and THE SOUTHERN GROUP OF FLORIDA, INC., a Florida corporation, hereinafter referred to as "CONTRACTOR".

#### WITNESSETH:

WHEREAS, CITY and CONTRACTOR entered into an Agreement for State Lobbying Services dated February 5, 2020, as well as a First Extension thereof dated January 14, 2021, a Second Extension thereof dated December 7, 2021, and a Third Extension thereof dated January 12, 2023, hereinafter collectively referred to as the Agreement, by which CONTRACTOR provides lobbying services to the Legislature and the Executive Branch of the State of Florida on behalf of CITY pursuant to RFP #20-08CM; and

WHEREAS, the Agreement, by its terms, is set to expire on February 4, 2024; and

WHEREAS, CITY and CONTRACTOR desire to enter into this Fourth Extension so as to extend the term of the Agreement for an additional period of three (3) months.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- 1. Section 4, Term, of the Agreement is hereby modified so as to extend the term thereof for an additional period of three (3) months. As modified, said Section 4 will provide as follows:
  - 4. <u>Term:</u> The term of this Agreement commenced on February 5, 2020. This Fourth Extension will become effective on February 5, 2024 and will expire at 11:59 p.m. on April 30, 2024. This Agreement cannot be extended.
- 2. Except as expressly set forth herein, all of the terms, covenants and conditions of the Agreement are hereby ratified and confirmed by CITY and CONTRACTOR and each, by the execution of this Fourth Extension of Agreement for State Lobbying Services, hereby signifies their intent to be bound thereby.

### To withdraw your consent with City of Sarasota

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:
