### V. DESCRIBE THE POTENTIAL IMPACT OF THE BILL ON PRESENT GOVERNMENTAL SERVICES:

The private facility currently utilized by the Town of Orchid for public meetings is offered free of charge, but that cannot be assumed to be guaranteed to continue in perpetuity. Not having any other viable locations to meet available within the Town, makes the Town vulnerable in several respects, including economically. The local bill will provide the Town with the ability to hold meetings without dependence on the limited availability of a very popular private facility. Scheduling meetings promptly and allowing ample time for consideration of the myriad matters that are attended to at public meetings is vital to the Town performing optimally in service to the community.

### VI. SPECIFIC DATA USED IN REACHING ESTIMATES:

The current Town Hall was used in the past for public meetings, as permitted by statute then, so it's known that the facility can be functional for that purpose. Noted expenses are based on the cost of additional furnishings to be purchased in the first fiscal year, as determined by the anticipated need and current pricing.

Also considered for this statement is the fact that the Town may choose to occupy a different facility for its Town Hall in the near future, within the bill's permitted perimeter, but that is unknown at this stage and not specifically related to this local bill. The cost of furnishings would still apply.

A small cost reduction, not previously noted, would be enjoyed by the Town in regard to the monthly mileage reimbursement for staff to travel to public meetings away from Town Hall. This would amount to approximately \$200 a year in cost savings.
