Notice is hereby given of intent to apply to the 2019 Legislature, in the 2019 regular or any special or extended legislative sessions, for passage of an act relating to the Town of Ocean Breeze, Martin County amending Florida Statutes Section 166.0213 (1) "Governing body meeting," as follows:

The governing body of a municipality having a population of 500 or fewer residents may hold meetings within 5 miles of the exterior jurisdictional boundary of the municipality at such time and place as may be prescribed by ordinance or resolution, provided the Town of Ocean Breeze in Martin County may hold its public meetings within 2.5 miles of its exterior jurisdictional boundary as long as its resident population does not exceed 1,500 persons.
