Notice is hereby given that the following bill will be presented to the 2020 Legislative Session of the Florida Legislature for consideration and enactment.

A BILL TO BE ENTITLED

AN ACT RELATING TO BROWARD COUNTY; PROVIDING FOR THE CREATION OF A COUNTYWIDE INDEPENDENT SPECIAL DISTRICT TO PROVIDE AND FUND SENIOR SERVICES THROUGHOUT BROWARD COUNTY; PROVIDING FOR A GOVERNING BOARD TO BE KNOWN AS THE SENIOR SERVICES COUNCIL OF BROWARD COUNTY; PROVIDING FOR MEMBERSHIP; PROVIDING FOR THE COUNCIL'S POWERS AND DUTIES; PROVIDING FOR BUDGET PROCEDURES; AUTHORIZING THE LEVY OF AD VALOREM TAXES NOT TO EXCEED ONE-HALF MILL; PROVIDING FOR ADDITIONAL DISTRICT POWERS, DUTIES, RESPONSIBILITIES AND OBLIGATIONS; PROVIDING FOR DISSOLUTION AND RETENTION OF THE DISTRICT; PROVIDING FOR A REFERENDUM AND BALLOT QUESTION; PROVIDING AN EFFECTIVE DATE.
