The U.S. Fish and Wildlife Service developed a Florida Scrub Jay Umbrella Habitat Conservation Plan and Environmental Assessment in 2007 to address challenges associated with complying with the Endangered Species Act. County-wide HCP?s were identified as the most comprehensive alternative for scrub jay conservation due to the protection of habitat and management of larger land areas The primary challenge identified for county-wide HCP's is the substantial commitment of time and funding.
