These homes abutting the Intracoastal Waterway are the last homes in the Town on septic tanks which are poorly maintained and failing. The Town Commission ranked the septic tank conversion as a priority and partnered with the City of Pompano Beach to protect the public and environment from nutrient-loading contamination.
