The existing water mains are over 50 years old and are of cast iron construction. They are subject to frequent breaks and result in customer complaints due to rusty water. The City has experienced 30% water loss due to leaks and flushing. To remedy this problem, the City of Hawthorne has embarked upon a phased City-wide water main replacement project. The City has secured \$674,200 in the form of loan and principal forgiveness from FDEP DWSRF for planning and design.
