The FRDLP will serve counties with = or < 7,500 students, which includes 25 of the total 67 counties (~81,342 K-12 students). The curricula will include rigorous instruction, projects, applications, and other interactive and engaging content that help students build the digital literacy skills that are foundational to STEM and CTE programs. Teachers will receive training and ongoing support.
