A Memorandum of Understanding in support of the Marine Research Hub was executed between the following entities: Each President of FAU, FIU, NSU, and UM; the CEO's of the Business Development Board of Palm Beach County; the Greater Ft. Lauderdale Alliance; the Miami Beacon Council; and the Marine Industries Association of South Florida. In addition, Broward County and Miami-Dade County have each committed a \$50,000 grant to the Marine Research Hub.

In January 2018, OPPAGA released a Research Memorandum providing an overview of the Marine Research Hub, marine-related research currently taking place within the state and the economic impact of marine-related industries to the state, among other things. The report also documented the types of marine-related research taking place at the various universities (\$129M invested in 2015-16). The report concludes that a database/platform is critical for the MRH to be able to execute its mission.
