To provide home delivered meals to 825 a day to frail, homebound elderly residents who are on the home delivered meal waiting list in Osceola County. Almost 1,000 older adults are on the waiting list. In addition to providing a nutritious meal, this program provides a safety check, and sometimes the only opportunity for face-to-face contact for that day, reducing the isolation that many older adults experience and linking them to additional services if needed.
