Osceola County, in collaboration with TWA, are creating a large regional stormwater and alternative water supply reservoir called the Lake Toho Water Restoration Project. This includes design and construction of a diversion wall, berm, or combination of the two that will divert flow from older parts of the community that have nutrient laden runoff and effectively taking the nutrients out of Lake Toho. It is estimated to remove 25,500 lbs of total Nitrogen, and 2,700 lbs of total Phosphorus.
