Dear Rep. Drake:

Per our discussion, we would ask that the following information be included in the Holmes County Appropriations Project Request, HB 3929. This statement should clarify the use of the funds for each phase of the proposed project.

"The funds shall be used for the creation of the Holmes County Consolidated Government Efficiency Center to be addressed in three phases: to build a new Ag Center Extension Office on county property adjacent to the state-owned Ag Center property at an estimated total cost of \$325,000; the purchase of the Holmes County Ag Center property currently owned by the state at a cost of no more than \$250,000; and \$500,000 toward a portion of the construction of a new EMS/law enforcement facility on county property adjacent to the state-owned Ag Center property at an estimated total cost of \$2,320,000 million. Should the APR be funded at more or less than \$1,500,000, the funds shall be utilized of the Holmes County Consolidated Government Efficiency Center shall be spent, first for the full amount of the construction of Extension Office, for the purchase of the Ag Center property. Any remaining funds shall be used to fund a portion of the construction of the new EMS/Law enforcement facility."

Please let us know if you need any additional information. The County is in full support of HB 3929 and we look forward to getting support of the full Legislature.
