As a result of the funding, over two thousand inmates will receive comprehensive vocational training and be placed with an employer. The program will provide long-term, full time employment to these adult inmates throughout the state of Florida. There is a 30% recidivism rate for inmates within the first three years of release. There is also a 15% recidivism over three years for work release inmates.
