Remove line(s) 22 and insert:
allowed by rules of the commission; providing unclaimed
confiscated wildlife, freshwater fish, or saltwater fish, to be
disposed of by the investigating law enforcement agency;
providing that state county, or municipal law enforcement
agencies are entitled to receive all or a share of any forfeited
property based upon their participation in investigating an
enforcement case; creates s. 372.731,
