

To the Members of the Florida House Redistricting Committee: The National Association for the Advancement of Colored People's primary objective is to ensure the political, educational, social and economic equality of all minority group citizens in the United States. As such, the Florida NAACP and its local chapters have been intimately involved in the advancement of minority political power in this state. As many of you know, Florida contains five section 5 protected counties that subject us to preclearance from the U.S. Department of Justice for any changes to voting procedures in the state. These Section 5 counties include Hillsborough County, which shares an African-American opportunity Senate district with Manatee and Pinellas Counties. We are deeply concerned with the Senate plan voted out of the full Senate Friday because /1s drops the Voting Age Population of the district below the benchmark number of 40 percent. At 37 percent we are concerned that this drop in performance, in addition to changing demographics in the Tampa Bay region, would substantially increase the possibility the African-Americans would be denied the ability to elect a candidate of their choice. We therefore ask that members of the House Redistricting Committee consider a proposal that is more closely aligned in performance to the benchmark number of 40 percent. We would greatly appreciate your interest in this important matter.
