Department of Agriculture & Consumer Services

Florida Department of Agriculture and Consumer Services 2024 - 2025 Legislative and Budget Priorities WILTON SIMPSON, COMMISSIONER OF AGRICULTURE



SUPPORTING PRODUCERS IMPACTED BY HURRICANE IDALIA

- Funding to support timber landowners with grants for the initial cost of site preparation, seedlings, and the planting of seedlings.
- Funding to support cost-share assistance for producers repairing or replacing damaged irrigation systems, while simultaneously promoting agricultural water and nutrient efficiency.



PRESERVING WORKING AGRICULTURAL LANDS

\$300 million in funding for the Rural and Family Lands Protection Program, which partners with willing farmers to preserve from development working agricultural lands and their immense economic and environmental benefits.



SUPPORTING FIRST RESPONDERS

- Funding to increase critical law enforcement capabilities and acquire needed equipment for the Office of Agricultural Law enforcement.
- Funding to replace aging wildfire suppression equipment to support Florida Forest Services' wildland firefighters in their mission to protect communities and resources from wildfire.



SUPPORTING FLORIDA'S FUTURE FARMERS

Providing Florida school districts the ability to approve 4-H and FFA related activities as excused absences.



DEFENDING SECOND AMENDMENT RIGHTS

- Removing prohibition on exercising Second Amendment rights while performing certain regulated services
- Making it more convenient for Floridians to renew and replace their concealed weapon licenses if they choose to receive one.



PROTECTING AGRICULTURAL PRODUCERS

- Funding to continue efforts to mitigate damages from pests, diseases, and natural disasters.
- Protecting Florida's food and fiber production by providing criminal penalties for trespassing on commercial agricultural property with the intent to commit a crime.
- Combatting saw palmetto berry theft by prohibiting the harvest, transport, processing or purchase of saw palmetto berries without a valid permit and permission from landowners.



SUPPORTING FLORIDA CONSUMERS

Providing increased transparency into Florida's charitable organizations, safeguarding consumers' household goods while being transported by interstate movers, requiring pest control companies to provide customers with documentation for all wood-destroying organism inspection/treatments.



MODERNIZING DEPARTMENT'S PROCESSES, PROCEDURES

- Funding to continue design and construction of new facility at FDACS Conner Complex to consolidate owned and leased space in Tallahassee.
- Streamlining and modernizing the department's customer service, operations, procedures, practices, and processes to better serve customers, businesses, and stakeholders.











Fiscal Year 2024-2025 Legislative Budget Request



- Florida Boating Improvement Program \$3M TF






FY2024-25 Legislative Budget Request Presentation





The Florida Department of Citrus (FDOC)

- Established by Legislature in 1935 at request of Industry to:
 - Protect health and welfare of citrus industry
 - Protect and enhance the quality and reputation of Florida citrus fruit and Florida citrus products
- 11-member Florida Citrus Commission appointed by Governor
- Chapter 601 "Florida Citrus Code" ratified in 1949
- Funded by growers through an assessment on each box of fruit that enters the primary channels of trade in the state







FDOC Mission Statement

Maximize consumer demand for Florida citrus products to ensure the sustainability and economic well-being of the Florida citrus grower, the citrus industry and the State of Florida.

Established September 2012, Florida Citrus Commission

Marketing & Public Relations

 Promote Florida citrus through marketing and public relations campaigns both Domestic and International

Research

- Scientific research with emphasis on health and wellness benefits, and HLB resistant trees

 Administrative duties of the department, as well as serving as liaison to Commission, Governor's Office, the Legislature and Congress







- Nonrecurring Marketing, \$5.0 million continuation and expansion of eCommerce and digital marketing programs




