Effective Date: upon becoming a law

**Compensation of County Officials;** Authorizes each county commissioner, circuit court clerk, county comptroller, sheriff, supervisor of elections, property appraiser, & tax collector to reduce his or her salary on voluntary basis. Effective Date: July 1, 2011

**Florida College System Institutions;** Renames Gulf Coast Community College as "Gulf Coast State College"; renames Pensacola Junior College as "Pensacola State College"; renames St. Johns River Community College as "St. Johns River State College"; renames Valencia Community College as "Valencia College." Effective Date: July 1, 2011

Education Committee: Favorable

**HB 61 by Rogers, Campbell, Clarke-Reed** (Similar SB 228)

**Code of Student Conduct;** Requires each district school board code of student conduct to include explanation of student responsibilities with regard to appropriate student dress; requires each district school board to adopt dress code policy that

prohibits student from wearing clothing that exposes underwear or body parts in specified manner; provides disciplinary actions for violation of dress code; requires adherence to code of student conduct for participation in extracurricular activities. Effective Date: July 1, 2011

**HB 65 by Wood** (Identical SB 298)

**Municipal Governing Body Meetings;** Authorizes governing bodies of certain municipalities to hold meetings within specified boundaries. Effective Date: July 1, 2011

Economic Affairs Committee: Favorable

**CS/HB 105 by Judiciary Committee, Goodson, Baxley, Van Zant** (Similar CS/SB 746)

**Open House Parties;** Provides that person who violates open house party statute second or subsequent time commits misdemeanor of first degree; provides that person commits misdemeanor of first degree if violation of open house party statute causes serious bodily injury or death. Effective Date: July 1, 2011

Judiciary Committee: Favorable With Committee Substitute

**CS/HB 107 by Government Operations Subcommittee, Smith, Campbell, Mayfield** (Similar SB 224)

**Local Government Accountability;** Revises provisions relating to procedures for declaring special districts inactive; specifies level of detail required for local governmental entity's proposed budget; revises provisions for local governmental entity's audit & annual financial reports; requires local governmental entity's budget to be posted online; revises budgetary guidelines for district school boards. Effective Date: October 1, 2011

Economic Affairs Committee: Favorable

**CS/HB 125 by Agriculture & Natural Resources Subcommittee, Kiar, Brandes, Garcia, O'Toole, Pafford, Randolph** (Similar SB 344)

**Animal Cruelty;** Prohibits knowing sexual conduct or sexual contact with an animal; prohibits specified related activities; provides that act does not apply to certain husbandry, conformation judging, & veterinary practices. Effective Date: October 1, 2011

**HM 189 by Ray, Holder**

**Free Trade Agreements Between the United States and Colombia, Panama, and the Republic of Korea;** Supports establishment of Free Trade Agreements between United States

& Colombia, Panama, & Republic of Korea.

**CS/HB 227 by Government Operations Subcommittee, Brandes, Ahern, Arfiles, Baxley, Corcoran, Ford, Horner, Metz, Renuart, Smith, Steube, Van Zant** (Identical CS/SB 378)

**Federal Write-in Absentee Ballot;** Authorizes absent uniformed services voters & overseas voters to use federal write-in absentee ballot to vote in any federal & certain state or local elections, under certain circumstances; prescribes requirements for designating candidate choices; provides for disposition of valid votes involving joint candidacies; allows for abbreviations, misspellings, & other minor variations in name of office, candidate, or political party; authorizes submission of multiple ballots under certain circumstances; details circumstances under which votes in federal, state, & local races on federal write-in absentee ballot will be canvassed; establishes certain canvassing procedures for federal write-in absentee ballots; directs Department of State to adopt rules to determine what constitutes valid vote on federal write-in absentee ballot; provides restrictions; provides minimum requirements; conforms provisions to changes made by act. Effective Date: July 1, 2011
