Blood Establishments; Redefines "blood establishment" & defines "volunteer donor"; prohibits local governments from restricting access to public facilities or infrastructure for certain activities based on whether blood establishment is operating as for-profit organization or not-for-profit organization; authorizes DLA to assess civil penalty against blood establishment that fails to disclose specified information on Internet; redefines "health care entity" to clarify that blood establishment is health

care entity that may engage in certain activities; exempts certain blood establishments from requirements to be permitted as prescription drug manufacturer & register products; requires certain blood establishments to obtain restricted prescription drug distributor permit under specified conditions; limits prescription drugs that blood establishment may distribute under restricted prescription drug distributor permit; authorizes DOH to adopt rules regarding distribution of prescription drugs by blood establishments. Effective Date: July 1, 2011

HB 201 by O'Toole (Similar SB 142)

Negligence; Defines "negligence action" & "products liability action"; requires trier of fact to consider fault of all parties to accident when apportioning damages in products liability action alleging additional or enhanced injury; provides legislative findings & intent; provides for retroactive application. Effective Date: upon becoming a law

HB 203 by Thurston (Identical SB 460)

Resisting an Officer or Other Specified Person Without Violence; Provides that resistance, obstruction, or opposition must be based on factors other than mere flight from officer or other person to whom this section applies. Effective Date: July 1, 2011

HB 205 by Roberson, K. (Identical SB 304)

Illegal or Undocumented Aliens; Requires DOC & Parole Commission to establish agreements to implement federal deportation program for state inmates; revises provisions relating to Control Release Authority; requires authority to implement program to execute immediate deportation; authorizes authority to extend or advance control release date for transfer of custody pending deportation; requires DOC to identify inmates eligible for control release for removal & deportation at reception; requires DOC to coordinate with federal authorities to determine immigration status & eligibility for removal; requires DOC to identify eligible inmates who waive administrative & appellate rights & who agree to cooperate; requires Control Release Authority to establish control release dates; authorizes setting control release dates after alien has served 50% of sentence; requires DOC to maintain control & responsibility for custody & transport of alien until transferred to federal custody; requires Control Release Authority to give notice to aliens concerning reentering U.S.; prohibits aliens from benefiting from control release awards when removal is not reasonably foreseeable. Effective Date: July 1, 2011

Term Limits; Proposes amendment of s. 15, Art. III & s. 4, Art VI & creation of provision in Art. XII of State Constitution to increase length of terms of state senators to 6 years & state representatives to 4 years & limit state senators & state representatives to 12 consecutive years in office.

HR 209 by Gibbons (Similar SR 192)

Fire Equipment; Encourages donation of surplus fire

equipment & materials to Florida's volunteer fire departments.

HB 211 by Passidomo, Smith

Florida Clean Indoor Air Act; Limits state preemption of regulation of smoking to indoor smoking. Effective Date: July 1, 2011

HB 213 by Bullard (Identical SB 448)

Bullying of School Children; Revises provisions relating to prohibited bullying or harassment with respect to computer-related incidents; redefines term "bullying" to include emotional hurt; revises components of school district policy on bullying & harassment; requires investigation of complaint of computer-related incident. Effective Date: July 1, 2011

HB 215 by Abruzzo (Identical SB 450)

Emergency Management; Creates Postdisaster Relief Assistance Act; provides immunity from civil liability for providers of temporary housing & aid to emergency first responders & their immediate family members following declared emergency; provides nonapplicability; provides definitions. Effective Date: July 1, 2011

HB 217 by Plakon, Adkins

Gambling Devices; Creates "Electronic Machines and Devices for Sweepstakes Prohibited Act"; prohibits operation of electronic device to conduct sweepstakes through use of entertaining display or to promote such sweepstakes; limits power of DACS; prohibits gambling apparatus; revises provisions for amusement games or machines. Effective Date: upon becoming a law

HB 219 by Rehwinkel Vasilinda (Similar SB 282, Compare SB 156, SB 284)

Renewable Energy; Requires electric utilities to collect monthly systems charge from residential, commercial, & industrial customers; provides for deposit of collected funds into Sustainable & Renewable Energy Policy Trust Fund; creates direct-support organization for Florida Energy & Climate Commission; requires contract between office & direct-support organization; provides for use of funds; requires annual audit; requires that purchase contract offered to producers of renewable energy contain payment provisions for energy & capacity based upon public utility's equivalent cost-recovery rate for certain clean energy projects; extends period of time for which residents are eligible to receive rebates for specified solar energy systems; provides schedule for rebate amounts. Effective Date: July 1, 2011

HB 221 by Rehwinkel Vasilinda (Compare SB 282, SB 284)

Trust Funds/Sustainable and Renewable Energy Policy
Trust Fund/Florida Energy Office/DEP; Creates Sustainable
and Renewable Energy Policy Trust Fund within Florida Energy
Office of DEP; provides for sources of funds, purposes, &
annual carryforward of funds; provides for future review &

termination or re-creation of trust fund; provides for contingent effective date. Effective Date: on the same date that House Bill 219 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes law

HB 223 by Hudson

Water and Wastewater Utilities; Provides for recovery through surcharge of costs for water & wastewater system improvement projects; requires PSC approval of surcharge; limits surcharge amount; provides requirements for surcharge billing, reconciliation, & adjustment; provides project eligibility criteria; provides requirements for notice, maintenance, & availability of certain records. Effective Date: July 1, 2011

HB 225 by Costello (Identical SB 446)

Dentistry and Dental Hygiene; Revises scope & area of practice for dental hygienists; revises locations at which dental hygienists may perform dental charting; authorizes dental hygienists to perform certain duties without supervision or authorization by dentist; requires that dental hygienists in health access setting provide certain disclaimer to patients before procedure is performed; provides that health access setting may bill for certain services; requires that dental hygienists provide referral, encourage establishment of dental home, & maintain insurance coverage in specified circumstances. Effective Date: upon becoming a law

HB 227 by Brandes (Identical SB 378)

Voting Methods and Procedure; Permits absent uniformed services voters or overseas voters to use Official Federal Write-In Absentee ballot or similar ballot to vote in any federal, state, or local election. Effective Date: July 1, 2011

HB 229 by Young

City of Tampa, Hillsborough County; Revises General Employees' Pension Plan for city; revises definitions of terms "Salaries or Wages," "Employee," & "Military Service Time"; revises application of term "Actuarial Equivalent"; defines term "Limitation Year"; provides that all employee contributions to pension fund after certain date are mandatory & that city shall pay such contributions to fund on behalf of employee; provides certain beneficiaries option to roll over certain death benefits; provides for refund of employee contributions; revises provision that addresses reemployment of retired employees; revises construction of act; allows DROP members annual election to elect investment option, as determined by board of trustees, to be applied to participant's account for plan year entering DROP program & for each subsequent plan year; revises benefit limitations; revises requirements for distribution of benefits; provides default distribution when member fails to elect distribution option; revises direct rollover options; revises terms "eligible rollover distribution," "eligible rollover plan," & "distributee." HB 231 by Young

City Pension Fund for Firefighters and Police Officers in the

City of Tampa, Hillsborough County; Authorizes City of Tampa to enter into supplemental contract with certain firefighters & police officers to comply with ch. 2009-97, Laws of Florida; revises manner in which elective trustees are elected; increases maximum length of time prior to term commencement in which to conduct trustee elections; allows board to retain services of more than one nationally recognized professional investment counselor; increases investment cap on foreign securities; provides that investment cap on foreign securities may not be revised, amended, increased, or repealed except as provided by general law; allows retired members to elect to receive reduced retirement benefit in order to provide surviving spouse benefit under certain circumstances; allows members to purchase up to an additional 5 years of credited service based upon prior service as full-time certified firefighter or certified police officer or for military service in U.S. Armed Forces subject to certain conditions; allows DROP participants upon entering DROP & annually thereafter to elect option for accruing annual interest at low-risk variable rate selected annually by board in lieu of rate reflecting fund's net investment performance as determined by board; prohibits members from selecting certain pension contract changes & rejecting others; confirms in part City of Tampa Firefighters & Police Officers Pension Contract; provides severability. HB 233 by Young

City of Tampa, Hillsborough County; Authorizes Division of Alcoholic Beverages & Tobacco of DBPR to issue alcoholic beverage license to City of Tampa to use within Curtis Hixon Waterfront Park & Kiley Garden Park; provides that license may be used only for special events; provides for payment of license fee; prohibits sales for consumption off premises; authorizes transfer & provides for subsequent reversion of license under certain circumstances. Effective Date: upon becoming a law

HB 235 by Chestnut

Lewd or Lascivious Offenses; Revises definition of term "sexual activity" for purposes of provisions relating to certain lewd or lascivious offenses. Effective Date: July 1, 2011

HB 237 by Williams, T. (Similar SB 136)

Enforcement of Immigration Laws; Provides legislative intent; prohibits state or political subdivisions from limiting or restricting enforcement of immigration laws; requires law enforcement officer to request citizenship information; authorizes law enforcement agency to transport alien to federal facility; requires judicial authorization for transfer of alien outside state; allows governmental entities to share information regarding citizenship; authorizes citizens to sue state or political subdivision of state if state or subdivision is restricting enforcement of federal immigration laws; provides for recovery of attorney's fees; provides for criminal penalties; prohibits probation or release of alien who does not possess registration documents; requires act be implemented consistent with federal law; prohibits law enforcement officers from using race as determining factor in assessment under act. HB 239 by Williams, T.

Numeric Nutrient Water Quality Criteria; Prohibits implementation of certain federal numeric nutrient water quality criteria rules by DEP, water management districts, & local governmental entities; authorizes DEP to adopt numeric nutrient water quality criteria for surface waters; provides that certain total maximum daily loads & associated numeric interpretations constitute site specific numeric nutrient water quality criteria; provides for effect, governance, & challenge of such criteria. Effective Date: July 1, 2011

HB 241 by Goodson

Wage Protection; Creates "Florida Wage Protection Law"; provides legislative findings & intent; preempts regulation of wage theft to state, except as otherwise provided by federal law, & supersedes any municipal or county ordinance or other local regulation on such subject. Effective Date: July 1, 2011

HB 243 by Workman (Similar SB 384)

Tangible Personal Property Taxation; Provides definitions; authorizes collection of tangible personal property tax recovery fee by person engaging in business of renting or leasing heavy equipment; specifies criteria & requirements for collection, retention, & return of recovery fee. Effective Date: July 1, 2011

HB 245 by Logan (Identical SB 406)

Florida Kidcare Program; Requires that application form for school breakfast & lunch programs also allow application for Kidcare program or provide information about applying for program; requires Florida Health Kids Corporation to include use of school breakfast & lunch application form in corporation's plan for publicizing program. Effective Date: July 1, 2011

HB 247 by Julien

Disabled Parking Permits; Provides for parking enforcement specialist or agency to validate compliance for disposition of citation issued for illegally parking in space provided for people who have disabilities; revises requirements for renewal or replacement of disabled parking permit; prohibits applying for new disabled parking permit for certain period of time upon second finding of guilt or plea of nolo contendere to unlawful use of such permit; requires DHSMV to audit disabled parking permit holders, verify certain information, & invalidate permit of deceased permitholder; directs department to implement means for reporting abuse of disabled parking permits; provides for department to conduct public awareness campaign. Effective Date: July 1, 2011

HB 249 by Berman

Public Corruption; Provides for reclassification of criminal offenses committed under color of law. Effective Date: July 1, 2011

HB 251 by Dorworth (Compare SB 488)

Sexual Offenses; Permits admission of evidence of defendant's commission of other crimes of sexual nature in criminal case in which defendant is charged with crime of sexual nature; requires property or material constituting child pornography used in criminal proceeding remain in care, custody, & control of state attorney or court; prohibits reproduction of such property or material by defendant when specified criteria are met by state attorney; permits access by defendant; requires emergency room to arrange for gathering of forensic medical evidence from victims who desire evidence for possible future report of sexual battery; provides for prosecution for video voyeurism within 1 year after victim of video voyeurism obtains actual knowledge of recording or recording is confiscated by law enforcement agency; requires additional court cost in cases of certain criminal offenses to be deposited into Rape Crisis Program Trust Fund; authorizes relocation assistance awards to sexual violence victims; requires that public schools provide health education addressing Internet safety. Effective Date: July 1, 2011

HB 253 by Stargel

Limited Liability Companies; Provides that charging order against member's transferable interest is sole & exclusive remedy available to enforce judgment creditor's unsatisfied judgment against member or member's transferee with respect to limited liability company; provides exception for enforcing judgment creditor's unsatisfied judgment against judgment debtor or assignee of judgment debtor of single-member limited liability company under certain circumstances; provides legislative intent; provides for retroactive application. Effective Date: upon becoming a law

HB 255 by Stargel

Parental Involvement and Accountability in the Public Schools; Specifies purpose to provide information & tools to parents of preK-12 students & to set standards for parental accountability; specifies causes for student underachievement; provides principles on which parental involvement is based & strategies to improve student achievement; requires shared information between teachers, schools, & parents; requires preK-3 teachers to assign parental involvement grade on student report cards; requires appeals process. Effective Date: July 1, 2011

HB 257 by Hooper (Similar SB 490)

Financial Responsibility for Medical Expenses of Pretrial Detainees or Sentenced Inmates; Provides that responsibility for paying for medical care, treatment, hospitalization, & transportation for person who is ill, wounded, or otherwise injured during or as result of arrest for violation of state law or county or municipal ordinance is responsibility of person receiving care or services; requires each in-custody pretrial detainee or sentenced inmate who receives medical care or other services to cooperate in seeking reimbursement for such expenses of facility; sets out order of resources from which third-party provider of medical services may seek reimbursement; requires each in-custody pretrial detainee or sentenced inmate who has health insurance, subscribes to health

care corporation, or receives health care benefits from any other source to assign such benefits to health care provider. Effective Date: July $1,\,2011$

HB 259 by Hooper (Similar SB 462)

Beverage Law; Provides that performing arts center, which has interest, directly or indirectly, in alcoholic beverage license is not required to obtain from Division of Alcoholic Beverages & Tobacco of DBPR approval of its volunteer officers or directors or any change of such positions or interests. Effective Date: July 1, 2011

HB 261 by Pilon (Identical SB 232)

Century Commission for a Sustainable Florida; Revises provisions relating to Century Commission for a Sustainable Florida; revises findings & intent; revises planning timeframes; revises membership of commission; deletes obsolete provisions; provides for election of chair; provides meeting requirements for commission; provides & revises powers & duties of executive director & commission; provides voting requirements; provides for reimbursement for per diem & travel expenses; requires that commission, in cooperation with interested state agencies, local governments, & nongovernmental stakeholders, develop strategic plan & submit plan to Governor & Legislature by specified date; provides commission reporting requirements; provides that executive director be appointed by Secretary of Community Affairs & ratified by commission; requires that DCA provide specific line item in its annual legislative budget request to fund commission during specified period; authorizes department to obtain additional funding through external grants; requires that department provide sufficient funding & staff support to assist commission in its duties; provides for future expiration & abolishment of commission. Effective Date: July 1, 2011

HJR 273 by Costello (Compare SJR 210, SJR 390)

Limitations on Annual Assessment Increases to Homestead and Nonhomestead Property; Proposes amendment to s. 4, Art. VII of State Constitution to prohibit annual increases in assessed value of homestead & nonhomestead property if just value of property decreases; limit annual assessment increases applicable to nonhomestead property to lower of specified percentage or percentage change in Consumer Price Index; & apply annual assessment increase limitations applicable to nonhomestead property to school district levies.

HB 275 by Caldwell

Certification of Child Welfare Personnel; Revises legislative intent; defines terms "child welfare certification" & "professional credentialing entity"; requires persons who provide child welfare services to be certified by professional credentialing entity approved by DCFS; provides requirements for department approval; deletes requirements relating to establishment of department training program, including training academies; revises use of department trust fund; deletes certain department rulemaking authority. Effective Date: July 1, 2011

HB 281 by Logan

Property Taxation; Conforms Taxpayer's Bill of Rights to revisions made by act; requires payment of specified percentage of tax bill before action contesting tax assessment may be brought in circuit court; conditions suspension of collection procedures upon payment of specified percentage; requires taxpayer refund or credit if final disposition results in amount owed that is less than percentage amount paid; deletes provisions relating to early payment discounts applicable after making request for correction of tax notice or mailing of tax notice that results from value adjustment board action; requires payment of specified percentage of tax bill on or before time certain before issuance of tax certificate or warrant may be stayed pending final action of value adjustment board; requires taxpayer refund or credit if final action results in amount owed that is less than percentage amount paid. Effective Date: July 1, 2011

HB 4001 by Diaz

Growth Policy; Repeals Urban Infill & Redevelopment Assistance Grant Program. Effective Date: July 1, 2011

HB 4003 by Diaz

Liens for Ginning Cotton; Repeals provisions relating to liens for labor or services in ginning cotton. Effective Date: July 1, 2011

HB 4005 by Gaetz

Legislative Records; Deletes provisions exempting from public disclosure certain records or information held by legislative branch & certain legislative draft documents & requests for

those documents or advisory opinions. Effective Date: July 1, 2011

HB 4007 by Workman

Driver Licenses; Repeals provisions relating to effect of classified licensure on persons holding chauffeur's license; repeals provisions for licensure of such persons under appropriate license classification. Effective Date: July 1, 2011

HB 4009 by Workman

Outdoor Theaters; Repeals provisions relating to access to public roads from outdoor theaters; removes provisions for entrances, exits, enclosures, vehicle storage, screen orientation, tower location, & driveway lighting; removes requirements for issuance of occupational license by tax collector. Effective Date: July 1, 2011

HB 4011 by Gaetz

Dance Studios; Repeals Dance Studio Act. Effective Date: July 1, 2011

HB 4013 by Eisnaugle

Television Picture Tubes; Repeals provisions relating to television picture tube labeling requirements. Effective Date: July 1, 2011

HB 4015 by Gaetz

Telemarketing; Deletes restrictions on business-to-business sales exemption of Florida Telemarketing Act. Effective Date: July 1, 2011

HB 4017 by Workman

Adultery, Cohabitation, and Lewd and Lascivious Behavior; Repeals provisions relating to living in open adultery; deletes language that made prohibition on couples lewdly & lasciviously associating & cohabiting together part of prohibition of lewd & lascivious behavior. Effective Date: July 1, 2011

HB 4019 by Workman

Traffic Offenses; Repeals provision that prohibits motor vehicle coasting on downgrade. Effective Date: upon becoming a law

HB 4021 by Workman

Water Vending Machines; Repeals provisions relating to regulation of water vending machines & permitting of water vending machine operators; deletes provisions for deposit of operator permitting fees, enforcement of state's water vending machine regulations, penalties, & preemption of county & municipal water vending machine regulations, to conform. Effective Date: July 1, 2011

HB 4023 by Plakon (Identical SB 474)

Sales Representative Contracts Involving Commissions; Repeals provisions relating to sales representative contracts involving commissions. Effective Date: July 1, 2011

HB 4025 by Gaetz

Yacht and Ship Brokers; Repeals Yacht & Ship Brokers' Act; removes provisions relating to licensing, escrow depository, closing transactions, & powers & duties of Division of Florida Condominiums, Timeshares, & Mobile Homes of Department of Business & Professional Regulation. Effective Date: July 1, 2011

HB 4027 by Horner

Obsolete Health Care Provisions; Repeals provisions relating to separate restrooms & dressing rooms for males & females, Florida Healthy People 2010 Program, & MedAccess program. Effective Date: July 1, 2011

HB 4029 by Horner

Transportation Corporations; Repeals Florida Transportation Corporation Act to remove provisions that provide for nonprofit corporations to act on behalf of DOT to secure & obtain rights-of-way for transportation systems & to assist in planning & design of such systems; removes provision for audits of such corporations by Auditor General to conform. Effective Date: July 1, 2011

HB 4031 by Dorworth

Local Government Services; Repeals statute relating to efficiency & accountability in local government services. Effective Date: July 1, 2011

HB 4033 by Dorworth

Florida Industrial Development Corporation; Repeals provisions relating to Florida Industrial Development Corporation. Effective Date: July 1, 2011

HB 4035 by Waldman (Identical SB 104)

Misdemeanor Pretrial Substance Abuse Programs; Provides that person who has previously been admitted to pretrial program may still qualify for voluntary admission to program. Effective Date: July 1, 2011

HB 4037 by Ahern

Entry by Law Enforcement Officers; Deletes provisions authorizing law enforcement officer to use all necessary & reasonable force to enter building or property where person to be arrested is or is reasonably believed to be after officer has announced his or her authority & purpose. Effective Date: July 1, 2011

HB 4039 by Diaz

Hypnosis; Repeals Hypnosis Law. Effective Date: July 1, 2011

HB 4041 by Diaz

Department of Children and Family Services Employees; Removes provision prohibiting federal, state, county, or municipal officer from serving as employee of DCFS. Effective Date: July 1, 2011

HB 4043 by Nelson

Florida Agricultural Museum; Repeals provisions establishing Florida Agricultural Museum & deletes related provisions pertaining to museum in provisions relating to DOACS' direct-support organizations for certain programs. Effective Date: July 1, 2011

HB 4045 by Hudson

Assisted Living Facilities; Repeals provision authorizing DEA to collect information regarding cost of providing certain services in facilities & to conduct field visits & audits; repeals provision authorizing local subsidy. Effective Date: July 1, 2011

HB 4047 by Hudson
