#### V. DESCRIBE THE POTENTIAL IMPACT OF THE BILL ON PRESENT GOVERNMENTAL SERVICES:

Government service providers will be better equipped to provide safety and security for the residents and business owners.

In terms of an economic impact model, researchers assume that all new revenues are spent on salaries. In this scenario, the model predicts the region may experience an increase in employment in fire services of 8 individuals. Up to 15 additional indirect and induced jobs may be achieved as a result of this change. Indirect, business to business, spending of approximately \$1.5M on fire security will also ripple through the economy.
