#### **SUMMARY ANALYSIS**

Current law provides a public records exemption for certain identification and location information of certain federal attorneys, judges, and magistrates, and their spouses and children. It does not provide a public records exemption for active duty servicemembers of the United States Armed Forces, Reserve Forces, or National Guard.

The bill creates a public records exemption for the identification and location information of current or former active duty servicemembers of the U.S. Armed Forces, Reserve Forces, or National Guard, and their spouses and children. In order for the exemption to apply, the current or former servicemember must submit to the custodial agency a written request and a written statement that reasonable efforts had been made to protect the identification and location information from being accessible through other means available to the public.

The bill defines the term "identification and location information" to mean the:

- Home address, telephone number, date of birth, and photograph of a current or former active duty servicemember of the U.S. Armed Forces, Reserve Forces, or National Guard;
- Home address, telephone number, date of birth, photograph, and place of employment of the spouse or child of such servicemember; and
- Name and location of the school or day care facility attended by the child of such servicemember.

The bill provides that the public records exemption is subject to the Open Government Sunset Review Act and will stand repealed on October 2, 2020, unless reviewed and saved from repeal through reenactment by the Legislature. It also provides a public necessity statement as required by the State Constitution.

The bill may have a fiscal impact on state and local governments. See FISCAL COMMENTS.

The bill has an effective date of October 1, 2015.

Article I, s. 24(c) of the State Constitution, requires a two-thirds vote of the members present and voting for final passage of a newly created or expanded public records or public meetings exemption. The bill creates a new public records exemption; thus, it requires a two-thirds vote for final passage.

#### **FULL ANALYSIS**

#### I. SUBSTANTIVE ANALYSIS

#### A. EFFECT OF PROPOSED CHANGES:

## **Background**

## Public Records Law

Article I, s. 24(a) of the State Constitution sets forth the state's public policy regarding access to government records. This section guarantees every person a right to inspect or copy any public record of the legislative, executive, and judicial branches of government.

Public policy regarding access to government records is addressed further in the Florida Statutes. Section 119.07(1), F.S., guarantees every person a right to inspect and copy any state, county, or municipal record.

## **Public Records Exemptions**

The Legislature may provide by general law for the exemption of records from the requirements of Article I, s. 24(a) of the State Constitution. The general law must state with specificity the public necessity justifying the exemption (public necessity statement) and must be no broader than necessary to accomplish its purpose.1

The Open Government Sunset Review Act<sup>2</sup> provides that a public records exemption may be created or maintained only if it serves an identifiable public purpose. In addition, it may be no broader than is necessary to meet one of the following purposes:<sup>3</sup>

- Allows the state or its political subdivisions to effectively and efficiently administer a governmental program, which administration would be significantly impaired without the exemption.
- Protects sensitive personal information that, if released, would be defamatory or would jeopardize an individual's safety; however, only the identity of an individual may be exempted under this provision.
- Protects trade or business secrets.

The Open Government Sunset Review Act requires the automatic repeal of a newly created exemption on October 2<sup>nd</sup> of the fifth year after creation or substantial amendment, unless the Legislature reenacts the exemption.4

### **Exempt versus Confidential and Exempt**

There is a difference between records the Legislature has determined to be exempt and those that have been determined to be confidential and exempt.<sup>5</sup> If the Legislature has determined the information to be confidential and exempt then the information is not subject to inspection by the public. 6 In addition, if the information is deemed to be confidential and exempt it may be released only to those persons and entities designated in statute. However, the agency is not prohibited from disclosing the records in all circumstances where the records are exempt only.

Current law provides a public records exemption for certain identification and location information of specified current or former agency employees and their spouses and children. Information such as home addresses, telephone numbers, a spouse's employer, and a child's school or daycare facility is exempt from public records requirements.

Current law also provides a public records exemption for certain identification and location information of the following federal personnel and their spouses and children:<sup>10</sup>

- United States attorneys and assistant U.S. attorneys;
- U.S. Courts of Appeal judges;
- U.S. district judges; and
- U.S. magistrates.

In order for the exemption to apply, the attorney, judge, or magistrate must submit to the custodial agency a written request to exempt the information from public records requirements. In addition, the attorney, judge, or magistrate must submit a written statement that he or she has made reasonable efforts to protect such information from being accessible through other means available to the public.<sup>11</sup>

Current law does not provide similar public records exemptions for active duty<sup>12</sup> servicemembers<sup>13</sup> of the U.S. Armed Forces, <sup>14</sup> Reserve Forces, or National Guard.<sup>15</sup>

# **Effect of Proposed Changes**

The bill creates a public records exemption for the identification and location information of current or former active duty servicemembers of the U.S. Armed Forces, Reserve Forces, or National Guard, and their spouses and children, and provides that the information is exempt from public records requirements. In order for the exemption to apply, the current or former servicemember must submit to the custodial agency a written request to exempt the information from public records requirements. In addition, the servicemember must submit a written statement that he or she has made reasonable efforts to protect the identification and location information from being accessible through other means available to the public.

The bill defines the term "identification and location information" to mean the:

- Home address, telephone number, date of birth, and photograph of a current or former active duty servicemember of the U.S. Armed Forces, Reserve Forces, or National Guard;
- Home address, telephone number, date of birth, photograph, and place of employment of the spouse or child of such servicemember; and
- Name and location of the school or day care facility attended by the child of such servicemember.

The public records exemption is subject to the Open Government Sunset Review Act and will stand repealed on October 2, 2020, unless reviewed and saved from repeal through reenactment by the Legislature. It also provides a public necessity statement as required by the State Constitution.

### **B. SECTION DIRECTORY:**

Section 1. Amends s. 119.071, F.S., creating a public records exemption for identification and location information of current or former active duty servicemembers of the U.S. Armed Forces, Reserve Forces, or National Guard, and their spouse and children.

- Section 2. Provides a public necessity statement.
- Section 3. Provides an effective date of October 1, 2015.

#### II. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT

### C. DIRECT ECONOMIC IMPACT ON PRIVATE SECTOR:

The bill does not appear to have any direct economic impact on the private sector.

#### D. FISCAL COMMENTS:

The bill could create a fiscal impact on state and local agencies with staff responsible for complying with public records requests as staff could require training related to the creation of the public record exemption. It is unclear whether the staff will experience an increase in workload due to the number of current or former active servicemembers who may take advantage of the public records exemption. In addition, an agency could incur costs associated with redacting the exempt information prior to releasing a record. The costs should be absorbed as they are part of the day-to-day responsibilities of the agency.

### **III. COMMENTS**

# A. CONSTITUTIONAL ISSUES:

### 1. Applicability of Municipality/County Mandates Provision:

The bill does not appear to require counties or municipalities to take an action requiring the expenditure of funds, reduce the authority that counties or municipalities have to raise revenue in the aggregate, nor reduce the percentage of state tax shared with counties or municipalities.

# Vote Requirement

Article 1, s. 24(c) of the State Constitution requires a two-thirds vote of the members present and voting for final passage of a newly created or expanded public record or public meeting exemption. The bill creates a new public records exemption; thus, it requires a two-thirds vote for final passage.

### **Public Necessity Statement**

Article I, s. 24(c) of the State Constitution requires a public necessity statement for a newly created or expanded public record or public meeting exemption. The bill creates a new public records exemption; thus, it includes a public necessity statement.

### Breadth of Exemption

Article I, s. 24(c) of the State Constitution requires a newly created public record or public meeting exemption to be no broader than necessary to accomplish the stated purpose of the law. The bill creates a new public records exemption related to certain identification and location information of a current or former active duty servicemember of the U.S. Armed Forces, Reserve Forces, or National Guard.

#### B. RULE-MAKING AUTHORITY:

The bill does not appear to create a need for executive branch rulemaking or rulemaking authority.

### C. DRAFTING ISSUES OR OTHER COMMENTS:

It is unclear how many current or former servicemembers will take advantage of the public records exemption and how the creation of the exemption will affect the workload of state and local government agencies. According to the Florida Department of Veterans' Affairs website, Florida has the third largest population of veterans in the nation with more than 1.6 million veterans living in Florida. In addition, there are at least 61,000 active duty servicemembers in Florida.

### IV. AMENDMENTS/ COMMITTEE SUBSTITUTE CHANGES

On February 11, 2015, the Veteran & Military Affairs Subcommittee adopted a strike all amendment to HB 185 and reported the bill favorably as a committee substitute. The amendment does the following:

- Moves the exemption from s. 119.071(4), F.S., to s. 119.071(5), F.S.;
- Revises the public necessity statement to clarify that the exemption protects sensitive personal
  information that would jeopardize an individual's safety- a revision that more closely aligns the public
  necessity statement to one of the public purposes listed in the Open Government Sunset Review Act;
- Requires a person to request the exemption in writing; and
- Requires a person to state in writing that they have made reasonable efforts to protect the information.

On March 24, 2015, the Government Operations Subcommittee adopted a strike-all amendment and reported the bill favorably as a committee substitute. The strike-all amendment revises the definition of "identification and location information" to include dates of birth. It also expands the public record exemption to make it applicable to any current or former active duty service member of the U.S. Armed Forces, Reserve Forces, or National Guard, instead of military special operations servicemembers only.

This analysis is drafted to the committee substitute as approved by the Government Operations Subcommittee.
