Remove line(s) 1479-1494 and insert:

6 with s. 99.061. Candidates shall pay a qualifying fee, which 7 shall consist of a filing fee and an election assessment or, as an alternative, shall file a petition signed by not less than 1 8 9 percent of the registered voters of the district, and take the 10 oath required in s. 99.021, with the supervisor of elections in 11 the county affected by such candidacy. The amount of the filing fee is 3 percent of \$4,800; however, if the electors have 12 13 provided for compensation pursuant to subsection (8), the amount of the filing fee is 3 percent of the maximum annual 14 15 compensation so provided. The amount of the election assessment is 1 percent of \$4,800; however, if the electors have provided 16 for compensation pursuant to subsection (8), the amount of the 17 18 election assessment is 1 percent of the maximum annual 19 compensation so provided. The filing fee and election assessment 20 shall be distributed as provided in s. 105.031(3).
