 2           An act relating to the official Florida Statutes; amending  
 3           ss. 11.2421, 11.2422, 11.2424, and 11.2425, F.S.; adopting  
 4           the Florida Statutes 2007 and designating the portions  
 5           thereof that are to constitute the official law of the  
 6           state; providing that the Florida Statutes 2007 shall be  
 7           effective immediately upon publication; providing that  
 8           general laws enacted during the 2006 regular session and  
 9           prior thereto and not included in the Florida Statutes  
 10          2007 are repealed; providing that general laws enacted  
 11          during the January 16-22, 2007, special session and the  
 12          2007 regular session are not repealed by this adoption  
 13          act.

 15 Be It Enacted by the Legislature of the State of Florida:

 17           Section 1. Section 11.2421, Florida Statutes, is amended to  
 18           read:

19           11.2421 Florida Statutes 2007 ~~2006~~ adopted.--The  
 20           accompanying revision, consolidation, and compilation of the  
 21           public statutes of 2006 ~~2005~~ of a general and permanent nature,  
 22           excepting tables, rules, indexes, and other related matter  
 23           contained therein, prepared by the Office of Legislative Services  
 24           under the provisions of s. 11.242, together with corrections,  
 25           changes, and amendments to and repeals of provisions of Florida  
 26           Statutes 2006 ~~2005~~ enacted in additional reviser's bill or bills  
 27           by the 2007 ~~2006~~ Legislature, is adopted and enacted as the  
 28           official statute law of the state under the title of "Florida  
 29           Statutes 2007 ~~2006~~" and shall take effect immediately upon

30 publication. Said statutes may be cited as "Florida Statutes 2007  
 31 ~~2006~~," "Florida Statutes," or "F.S. 2007 ~~2006~~."

32 Section 2. Section 11.2422, Florida Statutes, is amended to  
 33 read:

34 11.2422 Statutes repealed.--Every statute of a general and  
 35 permanent nature enacted by the State or by the Territory of  
 36 Florida at or prior to the 2006 ~~2005~~ regular legislative session,  
 37 and every part of such statute, not included in Florida Statutes  
 38 2007 ~~2006~~, as adopted by s. 11.2421, as amended, or recognized  
 39 and continued in force by reference therein or in ss. 11.2423 and  
 40 11.2424, as amended, is repealed.

41 Section 3. Section 11.2424, Florida Statutes, is amended to  
 42 read:

43 11.2424 Laws not repealed.--Laws enacted at the January 16-  
 44 22, 2007 ~~December 5-8, 2005~~, special session and the 2007 ~~2006~~  
 45 regular session are not repealed by the adoption and enactment of  
 46 the Florida Statutes 2007 ~~2006~~ by s. 11.2421, as amended, but  
 47 shall have full effect as if enacted after its said adoption and  
 48 enactment.

49 Section 4. Section 11.2425, Florida Statutes, is amended to  
 50 read:

51 11.2425 Rights reserved under repealed statutes.--The  
 52 repeal of any statute by the adoption and enactment of Florida  
 53 Statutes 2007 ~~2006~~, by s. 11.2421, as amended, shall not affect  
 54 any right accrued before such repeal or any civil remedy where a  
 55 suit is pending.

56 Section 5. This act shall take effect on the 60th day after  
 57 adjournment sine die of the session of the Legislature in which  
 58 enacted.
