 thereof that are to constitute the official law of the
 state; providing that the Florida Statutes 2008 shall be
 effective immediately upon publication; providing that
 general laws enacted during the June 12-14, 2007, special
 session and prior thereto and not included in the Florida
 Statutes 2008 are repealed; providing that general laws
 enacted during the October 2007 special sessions and the
 2008 regular session are not repealed by this adoption
 act; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

Section 1. Section 11.2421, Florida Statutes, is amended
 to read:

11.2421 Florida Statutes 2008 ~~2007~~ adopted.--The
 accompanying revision, consolidation, and compilation of the
 public statutes of 2007 ~~2006~~ of a general and permanent nature,
 excepting tables, rules, indexes, and other related matter
 contained therein, prepared by the Office of Legislative
 Services under the provisions of s. 11.242, together with
 corrections, changes, and amendments to and repeals of
 provisions of Florida Statutes 2007 ~~2006~~ enacted in additional
 reviser's bill or bills by the 2008 ~~2007~~ Legislature, is adopted
 and enacted as the official statute law of the state under the
