Section 2. Subsection (4) of section 189.4044, Florida Statutes, is amended to read:

189.4044 Special procedures for inactive districts.—

(4) The entity that created a special district declared inactive under this section must dissolve the special district by repealing its enabling laws or by other appropriate means. Notwithstanding this subsection or any other section of law, if the governing body of a special district unanimously adopts a resolution declaring the district inactive pursuant to subsections (1)(b) and (c), and no administrative appeals were timely filed, the special district may be dissolved without a referendum.
