Remove everything after the enacting clause and insert: Section 1. Subsection (8) is added to section 627.4133, Florida Statutes, to read:

627.4133 Notice of cancellation, nonrenewal, or renewal premium.—

(8) An insurer may, at the expiration of the policy term, transfer a commercial lines policy to another authorized insurer that is a member of the same group or owned by the same holding company as the transferring insurer. The transfer constitutes a renewal of the policy and may not be treated as a cancellation or a nonrenewal of the policy. The insurer must provide notice of its intent to transfer the policy at least 45 days prior to the effective date of the transfer along with the financial rating of the authorized insurer to which the policy is being transferred, and such notice may be provided in the notice of
