Amendment (with title amendment)

Remove everything after the enacting clause and insert: Section 1. Subsection (4) is added to section 468.604, Florida Statutes, to read:

8 468.604 Responsibilities of building code administrators, 9 plans examiners, and inspectors.-

10 (4) The Legislature finds that the electronic filing of 11 construction plans will increase governmental efficiency, reduce 12 costs, and increase timeliness of processing permits. If the 13 building code administrator or building official provides for 14 electronic filing, then construction plans, drawings, 15 specifications, reports, final documents, or documents prepared 16 or issued by a licensee may be dated and electronically signed 17 and sealed by the licensee in accordance with ss. 668.001-18 668.006, and transmitted electronically to the building code 19 administrator or building official for approval.
