- Subject to confirmation by the Senate
- Focuses on high-level policy decisions and has authority to adopt rules



What Happens After They Graduate? Standard Diplomas to Postsecondary











Florida steadily closing the achievement gap between White and African American students in Reading









Florida's Hispanic students charge ahead in Reading achievement









Florida's African American students make significant gains in Math








Hispanic student math achievement also on the rise







African American & Hispanic Graduation Rate up 10% in four years



Hispanics students have eliminated the achievement gap in AP in Florida




In 2004, 28% of Florida's graduating seniors took an AP exam in high school






By 2009, 40% of Florida's high school graduates took an AP exam






From 2004 to 2009, the percent of Florida's high school graduates earning an AP score of 3 or higher increased by 5% (third strongest in the country)






Steady Growth in Dual Enrollment participation and performance fuels Florida's College & Career Ready agenda






Number of Florida students earning Industry Certification skyrockets



- Public Charter Schools

(Magnet, Career Academies, Advance Placement, International Baccalaureate Program, controlled Open-Enrollment, etc.)



Provides scholarships to students with learning disabilities in K-12 to attend a public school other than the one they are assigned or a participating private school






Who is eligible?

- Students who have a current Individual Education Plan (IEP)
- Students who were enrolled and reported for funding in a Florida public school the year before you apply
- Must apply while still enrolled in public school
- One year exception for applicants for the 11-12 school year (HB 1505)

- Provides scholarships to students from low-income families
- Scholarships can be used to move to another public school or attend an approved private school
- Scholarships to private schools are approximately \$4100 for the 2010-11 school year
- Total scholarship funding available for 2010-2011 is \$140 million






Who is eligible?

- Students who are eligible for free or reduced price lunch, and
 - students who have been reported for funding in the year prior to applying to the scholarship program,
 - students who are entering kindergarten or 1st grade or
 - students who are foster children

Public Charter Schools

Independent public schools that are exempt from many K-12 regulations and can provide:

- theme-based education
- more chances for parent involvement
- alternative curriculum






Public Charter Schools

- Must be approved by the local school board
- If approved, must sign a performance-based contract with local school board
- Must employ certified teachers
- Curriculum must align with state standards
- Students take the FCAT and school is graded

Florida Virtual School Full time (FLVS FT): grades K-12 in partnership with Florida Connections Academy

- Florida Virtual School District Franchises (district specific)
- District Virtual Instruction Programs (required by law)





Home Education


- A parent-directed educational choice that allows the opportunity to explore and learn at the pace of the individual student
- Parents register each child in a home education program with their local school district
- No standard curriculum or attendance requirement for students
- A portfolio of records and materials showing student work must be maintained



What Happens After They Graduate? Standard Diplomas to Postsecondary






The Florida College System: Growth in FTE*




Florida College Transfers & SUS Enrollment



Independent Colleges & Universities

Institutions meeting the requirements of s. 1005.06(1)(c), F.S. (i.e., meeting FRAG requirements) are <u>not</u> under the purview of the Commission for Independent Education (CIE) and are <u>not</u> required to obtain licensure:

- Florida Resident Access Grant (FRAG) eligibility (s. 1009.89, F.S.):
 - Independent nonprofit college or university located in and chartered by the state.
 - Accredited by the Commission on Colleges of the Southern Association of Colleges and Schools.
 - Grants baccalaureate degrees.
 - Not a state university or state community college.
 - Has a secular purpose without "...excessive entanglement."

Independent Colleges & Universities of Florida (ICUF):


- 28 not-for-profit, degree-granting colleges & universities.
- All FRAG-eligible.
- None under purview of CIE or required to obtain licensure.
- Assigned to FLDOE, Office of Articulation, for administrative oversight.
- Example institutions: Barry University, Nova Southeastern University, University of Miami, etc.



Independent Colleges & Universities: Administrative Responsibilities Performed by the Department

- The Office of Articulation performs the following responsibilities associated with the oversight of private colleges and universities in Florida:
- 1. <u>Grants monitoring</u> -Administers grants totaling \$26,076,540 to 22 programs at 8 private colleges and universities in Florida. The Florida Resident Access Grant (FRAG) and Access to Better Learning and Education (ABLE) grant are administered by the Office of Student Financial Assistance.
- 2. Fair Consumer Practices -Collects the information pursuant to section 1005.04, Florida Statutes, from the 28 not-for-profit, degree-granting colleges & universities located in and chartered by the state. The Office also prepares the Physical Plant Safety report annually pursuant to section 1013.11, Florida Statutes.
- 3. Address Student Complaints -Refers students to existing institutional policies to resolve their concerns. In some cases, the Office follows-up with the concerned institution to ensure that the institution has published and followed its own procedures for addressing student complaints per section 1005.04(h), Florida Statutes.
- 4. <u>Legislative Budget Requests</u> (LBR) –Prepares the LBRs for the 8 private colleges and universities that receive line item appropriations from the Legislature annually.
- 5. Long Range Program Planning (LRPP) Annually updates the LRPP for the private colleges and universities in Florida.

MISSION of the Division of Vocational Rehabilitation

To provide services to eligible individuals with physical and/or mental impairments that will enable an individual to achieve an employment goal and/or enhance their independence.



Vocational Rehabilitation Program

- Authorized by the Federal Rehabilitation Act of 1973, as amended
- State is required to match the federal Vocational Rehabilitation grant award at a 21.3% state to a 78.7% federal ratio
- Chapter 413, Florida Statutes
- Policy follows federal Code of Federal Regulations (CFR)
- Key Performance Measure: number placed in jobs for at least 90 days. There were 3,878 successful employment outcomes in 2009-10

Injured Workers Program

- Bureau of Rehabilitation & Reemployment Services (BRRS)
 - Worker's Compensation Administrative Trust
 Fund
 - Assists Workers Injured on the Job to Return to Suitable, Gainful Employment
 - Assisted 1,236 Injured Workers return to work in FY 2009-10 with average annual earnings of \$24,756

3 Largest Programs

- Merit-Based Florida Bright Futures Scholarships
 - 181,802 students at \$437.3 Million
 - Initial eligibility based on college preparatory academic high school course grades and test scores
 - Renewal eligibility based on earned college credit hours and Grade Point Averages (GPA)
 - May attend most public and private universities, colleges and Career Centers in Florida
- Need-Based Florida Student Assistance Grants
 - 155,567 students at \$129.9 Million
 - All eligibility based on student financial need at their chosen institution and maintenance of a 2.0 GPA each year funded
 - May attend most public and private universities, colleges and Career Centers in Florida

3 Largest Programs, Cont.

- Tuition Assistance Florida Resident Access Grant
 - 34,580 students at \$83.9 Million
 - Eligibility based on resident status, full time enrollment and maintenance of a 2.0 GPA each year funded
 - May attend degree granting, independent, non-profit institutions in Florida, which are accredited by the Southern Association of Colleges and Schools

All Other Programs Combined

- 12 Additional Special Interest Programs
 - 24,069 students at \$34.9 Million
 - Eligibility based on individual program requirements
 - Renewal requirements of a 2.0 GPA required
 - Some programs recipients may only attend public institutions in Florida, others only private institutions in Florida and others may attend either public or private




Fall 2009 Enrollments

State University System of Florida

- Constitution and the Governance Agreement.
 - Board of Governors shall operate, regulate, control, and manage the State University System, subject to the Legislature's power to appropriate for the expenditure of funds.
- Board of Governors 17 members.

 - Selected by the Board of Governors.

 - Selected by the Board of Trustees; confirmed by the Board of Governors.







Proposed Substantive Issues 2011

- University Concurrency Trust Fund
 - Reestablish funding source to pay for infrastructure improvements related to university construction.
- Undergraduate Summer Term Attendance
 - Repeal section 1007.27(10), F.S., so that universities can more efficiently utilize facilities during the summer term.
- House Bill 7237 Clean-Up
 - Allow the Board of Governors to promulgate regulations instead of rules in certain instances.
