7 <u>A reward or incentive offered under this subsection is not a</u> 8 <u>violation of this section if it is disclosed in the policy or</u> 9 <u>certificate. This subsection does not prohibit insurers from</u> 10 <u>offering other incentives or rewards for adherence to a wellness</u> 11 <u>or health improvement program if otherwise authorized by state</u> 12 <u>or federal law.</u>
