**Deputy Commissioner**  
**Florida Department of Agriculture and Consumer Services**

Deputy Commissioner Levenstein joined FDACS in November 1993 and prior to his appointment current appointment, served as the Department of Ag's Director, State-Federal Relations; Legislative Affairs Director; Chief, Bureau of Animal Disease Control; and Senior Attorney. Presently, he oversees the Divisions of Consumer Services, Licensing, and Standards as well as the Office of Agricultural Law Enforcement. Mr. Levenstein holds a BS in Business Administration from the University of Florida and a law degree from the University of Miami.

Prior to his appointment as the Secretary, Charlie Liem had served as Department of Business and Professional Regulation's Chief of Staff.
