Between lines 81 and 82, insert:

- Section 1. Subsection (1) is amended and a new subsection (4) is added to section 20.22, Florida Statutes to read:
- 20.22 Department of Management Services.—There is created a Department of Management Services.
- (1) The head of the Department of Management Services is the Governor and Cabinet, who shall appoint an executive director Secretary of Management Services, who shall be appointed by the Governor, subject to confirmation by the Senate, and shall serve at the pleasure of the Governor.
- (4) The Agency for State Technology, created pursuant to s. 20.61, shall be administratively housed within the Department of Management Services.
