maintenance costs of the facility. A county levying the tax for the purposes in this subparagraph may do so only by a majority plus one vote of the membership of the board of county commissioners and after approval of the proposed use of the tax revenues by majority votes of the electors voting in referendums held in the county in which the facility is located and each contiguous county within 10 miles of the facility. (f) The applicant has signed an agreement to pay to the Department of Revenue for deposit in the General Revenue Fund amount equal to the proceeds from the sale of the bonds generated by pledging the funds distributed under s. 212.20 as debt service. Payment shall be indexed to the Consumer Price Index or a similar inflation indicator and shall include any interest expense accrued from the proceeds from the sale of the bonds generated. Payment shall be due within one year after the last distribution is made, but may be made at any time before that date.
