Implementation of 2013 Legislation

Florida Homeowners' Construction Industry Recovery Fund (FHCIRF) HB 57 Implementation

- The FHCIRF is a fund of last resort available to compensate homeowners who suffered monetary damages due to the financial misconduct or fraud of a construction contractor
- HB 57 permitted the transfer of excess funds from the Florida Building Code Administrators and Inspectors Board (BCAIB) to the FHCIRF when those funds are not necessary for the operation of the BCAIB
- Effective date was October 1, 2013

FY 2013-14

- Beginning Status
 - 589 pending claims valued at \$13,153,267 in anticipated recovery payments
- Annual Appropriation: \$8 Million
- Anticipated Claim Payout
 - -371 claims = \$7,986,624
- Remaining Claims
 - 218 claims valued at \$5,166,643 in anticipated recovery payments
- Claims Rate
 - Received an average of 333 claims per year during the previous 5 fiscal years

Craft Distilleries HB 347 Implementation

- The law creates/defines a new type of distillery, craft distilleries, and allows the distillery to sell their product to consumers in face-to-face transactions on retail premises contiguous to the distillery's premises.
- Craft Distillery is defined as a licensed distillery that produces 75,000 or fewer gallons of distilled spirits on it premises.
- Effective date was July 1, 2013.
- The law has been implemented: license type enabled in system and staff trained.

Florida Real Estate Appraisal Board (FREAB)

- Most recent compliance review determined that the FREAB is in substantial compliance with federal regulations
- Additional 3 attorney positions, 3 investigator positions, and 3 administrative assistant positions added to:
 - Ensure continued compliance
 - Allow DBPR to handle increased case loads and reduce or eliminate year old cases

FREAB

SB 1398 Implementation

- SB 1398 authorizes the FREAB to accept distance education courses for qualifying education
- Effective date was July 1, 2013
- The FREAB considered changes to Rule 61J1-4.001, F.A.C., to incorporate standards for distance education courses at its meeting on October 7, 2013

FREAB

HB 667 Implementation

- HB 667 authorizes the FREAB to incorporate the standards of the 2015 Appraiser Qualifications Board (AQB) into the Florida Statutes, effective January 1, 2014
- The official rulemaking process for further changes will commence January 1, 2014
- Rules anticipated to be developed with a specific effective date that will provide notice to appraisers, ensure adequate time to licensees and applicants, and comply with the federal deadline of January 1, 2015

Military and Veterans HB 887 (2012) Implementation

- Authorized the Department to waive the initial licensing fee, the initial application fee, and the initial unlicensed activity fee for military veterans who apply for a state professional license
- Application must be submitted within 24 months after an honorable discharge from any branch of the United States Armed Forces
- 120 fee waivers issued since implementation in July 2012
 - Total savings of \$15,741 to applicants

Military and Veterans HB 713 (2010) / HB 7129 (2010) Implementation

- Allowed spouses of active duty members of the Armed Forces of the United States stationed in Florida to receive a temporary license to practice a profession in Florida while obtaining a permanent license
- Applicant must hold a valid license for the profession in another state, District of Columbia, any United States territory or possession, or a foreign jurisdiction
- Issued 22 temporary licenses since implementation in July 2010

Licensure by Endorsement HB 887 (2012) Implementation - Cosmetology

- Allows cosmetologist applicants the ability to endorse their current license from another state whose requirements include completion of a minimum of 1200 educational hours and passage of a written examination.
- If the Department is able to verify the information by means of another state board's website, the applicant does not need to provide license certification from the endorsing state.
- This expedites the endorsement process and decreases fees paid for out-ofstate license verifications.

Licensure by Endorsement HB 769 (2012) Implementation Certified Public Accountants

- Allowed a CPA who had held an active license in good standing for at least 10 years, prior to Florida application, in another jurisdiction to qualify for licensure by evidencing current license and 80 hours of continuing professional education completed in the 24 month period preceding application in Florida.
- Endorsement applications approved
 - FY 2011-12: 518
 - FY 2012-13: 646

Licensure by Endorsement HB 517 (2012) Implementation - Architects

 Removed the separate educational verification requirement, and now allows an endorsement applicant with National Council of Architectural Registration Boards (NCARB) certification and valid licensure from another state to become licensed in Florida whether or not they hold a degree accredited by the National Architectural Accreditation Board (NAAB).

- Created a new avenue to licensure by endorsement for applicants who did not have the NAAB degree or NCARB certification, but had at least a 4-year degree, had passed the examination, held a valid license from another state, and had continuously lived in Florida for at least 10 years.
 - Approximately 20 individuals were eligible for this provision.
 - Provision expired on March 1, 2013.

Licensure by Endorsement Real Estate – Mutual Recognition

Florida Real Estate Appraisal Board (FREAB)

- FREAB has for many years allowed mutual recognition with states for many certified appraisers.
- The Dodd-Frank Act mandated that all states must have a mandatory reciprocity program in place by July 1, 2013. Florida is in compliance with this requirement and offers reciprocity through our mutual recognition process.

Florida Real Estate Commission (FREC)

- Since 2009, the number of mutual recognition agreements has been reduced by 3. None of these agreements were terminated by Florida.
- Currently, FREC is considering an agreement with the State of Illinois.

Florida Building Commission Screen Enclosures Workgroup SB 704 (2012) Implementation

- SB 704 (2012) required the Florida Building Commission to develop a rule for providing an alternative design method for screen enclosures.
- The rule was developed and provided a screen enclosure design method allowing for removal of screen sections to accommodate high-wind events.

Elevator Safety HB 663 (2010) Implementation

- Granted access to buildings containing elevators to Bureau Elevator Safety inspectors
- Provided authority to grant variances
 - Allow elevators to come into compliance without causing hardship on owners
- Highest compliance rate in recent Bureau history as a result of these changes and other Bureau activities
 - 98.81% of licenses current as of 7/29/2013
- Created Fire Fighter Service Phase II exemption
- Allowed the use of lockboxes to comply with Regional Fire Key Requirement

The filings that will be integrated into the portal comprise 95% of these filings, and of those filings, 75% were filed electronically. Phase I will also guide a new business through the process of registering a fictitious name. In calendar year 2012, the Department of State processed 95,950 fictitious name registrations, and of those filings, 89% were filed electronically.

Economic Opportunity	 Florida's Reemployment Assistance Program is administered by the Department of Economic Opportunity (DEO). This program imposes a tax on wages paid by Florida employers to pay for unemployment benefits received by unemployed individuals. The Department of Revenue provides tax collection services for the DEO. A new business using the One-Stop Business portal will be able to register with the Department of Revenue for this tax. Future phases of the project are anticipated to provide businesses with economic data from DEO.
Financial Services	 The Department of Financial Services provides businesses with helpful information regarding coverage requirements through its website. The Portal will provide a link to the Division of Workers' Compensation website for the purpose of educating businesses.
Management Services	The Department of Management Services operates the State of Florida's eProcurement system known as MyFloridaMarketPlace. The portal will provide new businesses with the opportunity to become a registered vendor. When a vendor registers with MyFloridaMarketPlace, state agencies are able to conduct business with the vendor for goods and services.
Lottery	 The Portal will provide referral information to The Florida Lottery for new businesses that wish to become authorized retailers.
III. Phase I Function	nality
Function	Description
Registration Wizard	 The Registration Wizard will guide a business through the registration and licensure process. It will ask the business a series of questions in order to identify which registrations or licenses are needed and it will capture all of the demographic information of the business such as its name, address, identifiers and telephone number. Once this information is captured, it will eliminate the need to enter this information again when applying for another registration or license. The portal will also include a dashboard which will provide the business with a status of the progress of its registration applications across agencies.
Single Business Identifier	 The Single Business Identifier will implement a unique business identifier for each business that will be shared across agencies. While the single business identifier is in addition to other identifiers that an agency may use (e.g. the federal employer identification number), it is the one number that will be used to identify a business in all systems.
Payment Gateway	• The Payment Gateway will provide the mechanism for accepting payments from businesses. Businesses will be able to pay for their registrations and licenses using credit cards, debit cards, and electronic funds transfers.
Fund Accounting	 The Fund Accounting function will take the payments received through the Payment Gateway and distribute the funds to the appropriate state agencies.
Web Services	 The Web Services function will provide two-way communication between the Portal and agency systems to ensure the delivery of all transactions.


