Dear Chairman Oliva:

House Bill 231 has passed through the three subcommittees of reference and has now been referred to the Economic Affairs Committee. House Bill 231 provides definitions for bodily injury, vulnerable users, and vulnerable users of a public right of way. The bill makes it unlawful to harass, taunt, or maliciously throw an object at or in the direction of a person riding a bicycle. HB 231 provides that in addition to any other penalty imposed, if a traffic violation contributed to the bodily injury of a vulnerable user, a fine of not more than \$2,000 shall be imposed and the driver license shall be suspended for 6 months.

I respectfully request that you place HB 231 on your committee agenda at the earliest opportunity. I am available to speak with you at your convenience if you have any questions about the bill. Thank you for your consideration.

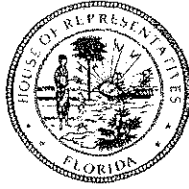
