
I respectfully request that you place HB 621 relating to Voluntary Contributions to End Breast Cancer on the *Economic Affairs Committee* agenda. This proposed legislation, if passed, add a voluntary contribution option to car registrations, new driver's license applications, and driver's license renewals of \$1 or more per applicant to "End Breast Cancer."

The contributions will be distributed by the department to the Florida Breast Cancer Coalition Research Foundation, Inc, a not-for-profit, and must be used for breast cancer research and education.

The breast cancer plate remains among the top 25 best-selling specialty plates with more than 20,000 plates sold. Those sales have resulted in more than \$3.5 million for breast cancer research and breast cancer education. All research and education grants are provided to Florida entities and all work is done in Florida.
