House Bill 451 has been referred to the Economic Development and Tourism Subcommittee. HB 451 allows for the extension of the Entertainment Industry Incentive Program which is a conservative program that credits companies once they have invested in and stimulated the Florida economy by employing the local workforce. In addition, HB 451 requires all production companies granted a credit to contribute a portion of the credit to a department certified workforce training program or institution of higher learning and requires those certified as a high impact production to provide internship opportunities to Florida residents as well as promote the Florida Tourism Industry Marketing Corporation via their website.
