Re: HB 197 - Tracking Devices or Applications

Dear Chair Artiles:

I am pleased to be the sponsor of House Bill 197, related to Tracking Devices and Applications. I respectfully request that this bill be placed on an agenda for hearing before the Economic Development & Tourism Subcommittee. In general, HB 197 would prohibit the installation of tracking devices or tracking applications on a person or their property, without that person's consent. Certain exceptions for proper uses of this technology are provided, including tracking in connection with lawful criminal investigations, parents tracking their children, tracking of an elderly or disabled person for safety reasons with a treating physician's certification, and in good faith for legitimate business purposes. The objective of the legislation is to prohibit the installment of this technology onto a person or their possession without their consent, for the purpose of invading their personal privacy or for stalking purposes. For additional background information I am enclosing a copy of an article entitled "Separating Stalkers from Tracking Technology" which appeared in the September 2014 addition of *State Legislatures* magazine.

I look forward to presenting this sound bill to your subcommittee. Thank you.
