Pursuant to House Rule 7.9, we are requesting authority for the Highway & Waterway Safety Subcommittee to proceed with a proposed committee bill relating to the Department of Highway Safety and Motor Vehicles (DHSMV).

The proposed committee bill will cover various issues related to DHSMV. Specific areas the bill will address are:

- Making uniform the number of days required to obtain an original or change of address for a driver license and/or motor vehicle registration for both new and current residents.
- Clarifying that the booster seat law for 4-5 year olds does not apply to day care facilities or child care providers when a seat belt is used.
- Providing for a no cost identification card to youth transitioning out of the Department of Juvenile Justice system into adulthood.
