Section 2. The Legislature finds that it is a public necessity that a court record relating to the settlement of a 9 10 ward's or minor's claim, including a petition for approval of a 11 settlement on behalf of a ward or minor, a report of a guardian ad litem relating to a pending settlement, or an order approving 12 13 a settlement on behalf of a ward or minor, be made confidential and exempt from s. 119.07(1), Florida Statutes, and s. 24(a), 14 15 Art.
