


## What is differentiated accountability (DA)?

- Section 1008.33, Florida Statutes, requires differentiated and escalating interventions and supports to non-charter schools receiving school grades of D or F
- Rule 6A-1.099811, Florida Administrative Code, establishes strategies, responsibilities, timelines and deliverables for implementation of DA
- Field teams embedded throughout the state serve as district and inter-agency liaisons to support improved outcomes for all students through strategic problem solving and capacity building in the areas of:
  - Accountable and Shared Leadership
  - Standards-based Instruction and Learning
  - Positive Culture and Environment




#### **Flowchart of DA Entry and Exit**





## Comparison of DA Results 2014 and 2016



## What is a turnaround option plan (TOP)?

- A TOP is a district plan for a school with two consecutive grades of F or any combination of three consecutive grades below C designed to "turn around" the performance of the school based on increasing student learning and performance
- Before implementation, a TOP requires:
  - Stakeholder engagement and data analysis to identify school needs (during the planning year)
  - Review by the regional executive director (RED)
  - State Board approval



### **Turnaround Options**

- District-managed Turnaround (DMT)
- Closure
- Charter
- External operator
- Hybrid

#### **State Board Options for Turnaround Plans**

The State Board may:

- Approve the new plan as proposed
- Conditionally approve the new plan with contingencies/conditions, such as modification or reporting (i.e., approve the new plan with directed changes)
- Defer its decision and require more information be provided (for example, clarification of the differences between the old and new plan) before deciding whether to approve the plan
- **Deny** the new plan



#### **Criteria For Approval Of All Plans**

- The Board must find that the plans "create the conditions to improve the school's grade during the two-year implementation period" and
- Plans must meet the applicable requirements set forth in Turnaround Option Plans (TOPs)
  - District may request to modify a TOP requirement where the modification will not impede school improvement

In every case, the ultimate question before the Board is whether the proposed plan has a reasonable chance of success

#### Next Steps if Plan is Denied by State Board

- With the Commissioner's recommendations, the State Board may deny a plan indicating the reasons and areas of deficiency
- The district must then submit a new plan
  - The new plan may be for a new option or a revision of the plan for an existing option, depending upon the deficiency



#### How long does a district implement a TOP?

- Year one May exit if improved to a C
- Year two If the school grade has not improved to a C, a new option is required by law
  - Exception: the State Board may grant additional time to implement if the district is able to demonstrate that the school is likely to improve to a C if it continues implementation for one more year
  - Once a new option is selected and State Board approved, the district has two years to implement



### **2016-17 TOP Implementers**

- Cycle 1: 74 schools majority implementing districtmanaged turnaround (DMT)
  - Year 1: 69 schools
  - Year 2: 3 schools
  - Year 3: 2 schools (received waiver to implement 3<sup>rd</sup> year)
- Cycle 2: 42 schools majority implementing a hybrid model
  - All are currently in Year 1 of a two-year plan
  - 2016-17 is the first cohort of Cycle 2
  - Must improve to a C by 2018 or select third option

#### **Cycle 2 Turnaround Plans**

- Turnaround plans for 42 schools in Cycle 2 went before the State Board for consideration in July, August and September of 2016
- Out of 67 districts, just 14 have one or more schools in Cycle 2
- This represents less than 1% of Florida's schools

In sum, almost all of school districts have demonstrated the capacity to successfully operate schools – less than one percent of schools require additional assistance and management to reach their goals.





#### **Persistently Low-Performing DA Schools**




