Use of Lights and Sirens on Emergency Vehicles; Authorizes driver of authorized emergency vehicle to exercise certain privileges when transporting organs or surgical teams for organ donation or transplant to certain locations; authorizes authorized emergency vehicles to operate emergency lights & sirens in emergency; authorizes organ transport vehicles to show or display red lights; authorizes organ transport vehicle to display or use red warning signals. Effective Date: July 1, 2024

Building Construction Regulations and System Warranties; Provides specified effective date for provisions relating to HVAC manufacturer's warranty transfers; prohibits HVAC manufacturer's warranties from being conditioned upon product registration; provides effective date for certain HVAC systems & components warranties under specified circumstance; provides required information for warranty & product registration cards & forms; prohibits HVAC systems & components warranties from being conditioned upon product registration. HB 521 by Koster (Identical SB 534)

Equitable Distribution of Marital Assets and Liabilities; Requires court to consider certain factors when determining if extraordinary circumstances exist; provides certain actions do not change whether real property is marital property; provides that business interests in closely held business is marital asset; requires court to consider certain factors when determining value of such interest; provides that certain real property is nonmarital asset. Effective Date: July 1, 2024

CS/HB 347 by Judiciary Committee, Truenow (Similar SB 1252)

Exemptions from Products Liability Actions; Specifies circumstances under which products liability actions may not be brought against agricultural employers, distributors, dealers, or applicators. Effective Date: July 1, 2024

Sovereign Immunity for Professional Firms; Provides applicability; requires that contracts with certain professional firms must, to extent permitted by law, provide indemnity to DOT. Effective Date: July 1, 2024

Alzheimer's Disease and Related Dementia Training for Law Enforcement Officers; Requires FDLE to establish online, continued employment training component relating to Alzheimer's disease & related forms of dementia; requires training component be developed with DOEA; specifies instruction requirements for training; authorizes completion of such training to count toward certain requirement. Effective Date: October 1, 2024

HB 601 by Duggan, Black, Roach (Compare CS/SB 576)

Complaints Against Law Enforcement and Correctional Officers; Preempts regulation of complaints against law enforcement officers & correctional officers to state. Effective Date: July 1, 2024

HB 937 by Casello (Identical CS/SB 640)

Purple Alert; Requires local law enforcement agencies to develop policies for local activation of Purple Alert for certain missing adults; specifies requirements; specifies duties of FDLE's Missing Endangered Persons Information Clearinghouse in event of state Purple Alert; specifies conditions under which local law enforcement agency may request clearinghouse to open case. Effective Date: July 1, 2024

Offenses Involving Critical Infrastructure; Provides criminal penalties for improperly tampering with critical infrastructure resulting in specified monetary damage or cost to restore; provides for civil liability upon conviction for such violations; provides criminal penalties for trespass upon critical infrastructure; provides notice requirements; provides criminal penalties for unauthorized access to or tampering with specified electronic devices or networks of critical infrastructure. Effective Date: July 1, 2024

HB 531 by Snyder (Identical SB 538)

Traveling Across County Lines to Commit Criminal Offenses; Provides for reclassification of certain offenses if person who commits offense travels with intent to commit offense in county other than person's county of residence. Effective Date: upon becoming a law

HB 533 by Fabricio, Alvarez, Beltran, Yarkosky (Identical SB 524)

DNA Samples from Inmates; Requires certain inmates to submit DNA samples. Effective Date: upon becoming a law

HB 1131 by Temple (Identical SB 1190)

Online Sting Operations Grant Program; Creates Online Sting Operations Grant Program within FDLE to support local law enforcement agencies in creating sting operations to protect children; requires FDLE to annually award grant funds; provides funding requirements. Effective Date: July 1, 2024

CS/CS/HB 1181 by Judiciary Committee, Criminal Justice Subcommittee, Jacques, Garcia, Yarkosky (Similar CS/SB 1274)

Juvenile Justice; Revises penalties for minors committing firearms violations; redesignates civil citation programs as delinquency citation programs; requires child on probation for felony firearm offense who is taken into custody be placed in secure detention; requires specified sanctions for certain children adjudicated for firearms offenses; requires DJJ to create graduated response matrix to hold youths accountable for probation & conditional release terms; authorizes exception to revocation or suspension of driving privileges in certain circumstances; requires DJJ to establish specified class for firearms offenders; revises provisions concerning introduction of contraband into DJJ facilities. Effective Date: July 1, 2024

Effective Date: upon becoming a law

HM 7065 by Judiciary Committee, Giallombardo (Identical SM 1020)

Designation of Drug Cartels as Foreign Terrorist Organizations; Urges Secretary of State to designate drug cartels as Foreign Terrorist Organizations.

Time allocations apply to all bills listed in Section A and any bill substituted for or taken up in lieu of a listed bill. Amendment sponsors shall have 2 minutes to open and 2 minutes to close, except as outlined below.

Except for the bills listed in Section C, the House shall spend no more than the following times:

- For each bill
 - Questions and answers 10 minutes
 - O Debate 5 minutes
- For each amendment:
 - O Questions and answers 5 minutes
 - O Debate 5 minutes

For all bills, along with their associated amendments, the time for questions and answers includes both the question and the answer and shall be no more than the times listed. Neither the question nor the answer shall be protracted in an attempt to use up the time.

Once more than 10 non-bill sponsor amendments are filed, the allocation of time spent on each non-bill sponsor amendment shall be determined as follows:

- 90 minutes divided by the total number of non-sponsor amendments filed.
- · The time allocated for each non-bill sponsor amendment shall be divided equally between the open, questions, debate, and close.
- Amendments withdrawn prior to consideration of the bill don't count toward the total.

For the bills listed in Section C, time spent on debate shall be allocated as specified, with the time equally divided. In addition to the allotted time, the sponsor will explain and close the bill, closing not to exceed 10 minutes. After opening, the debate managers identified below (or their designee) shall be alternately recognized until their time runs out. Time not utilized is lost.

• Debate managers may speak in debate and yield time to other Members to debate; no Member may be recognized for debate unless a debate manager yields time to that Member. Recognitions of debate managers must go through the Speaker. A Member may not be recognized more than once in debate on the bill or amendment.
