Effective Date: July 1, 2024

CS/CS/HB 385 by Judiciary Committee, Civil Justice Subcommittee, Rudman, Cassel, Canady, Hart, López, J., Maney, Michael, Yarkosky (Similar CS/SB 580)

**Safe Exchange of Minor Children;** Provides requirements for parenting plan relating to exchange of child; requires court to order parties to parenting plan to exchange child at neutral safe exchange location or supervised visitation program; requires sheriffs to designate areas as neutral safe exchange locations; provides immunity from liability; revises forms for injunctions for protection against domestic violence; requires court-ordered injunctions for protection against domestic violence; to designate locations for exchange of child of parties. Effective Date: July 1, 2024

#### CS/HB 461 by Judiciary Committee, Amesty (Similar CS/SB 462)

**Excusal from Jury Service;** Requires that woman who has recently given birth be excused from certain jury service under specified conditions. Effective Date: July 1, 2024

Civil Justice Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

#### CS/HB 487 by Judiciary Committee, Chaney, Basabe, Caruso (Compare SB 682)

Lost and Abandoned Property; Revises timeframes within which law enforcement officers must provide certain notices to owners of certain abandoned or lost properties. Effective Date: July 1, 2024

Criminal Justice Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

#### **B. PROCEDURES:**

Time allocations apply to all bills listed in Section A and any bill substituted for or taken up in lieu of a listed bill. Amendment sponsors shall have 2 minutes to open and 2 minutes to close, except as outlined below.

Except for the bills listed in Section C, the House shall spend no more than the following times:

- For each bill:
  - O Questions and answers 10 minutes
  - O Debate 5 minutes
- For each amendment:
  - <sup>o</sup> Questions and answers 5 minutes
  - O Debate 5 minutes

For all bills, along with their associated amendments, the time for questions and answers includes both the question and the answer and shall be no more than the times listed. Neither the question nor the answer shall be protracted in an attempt to use up the time.

Once more than 10 non-bill sponsor amendments are filed, the allocation of time spent on each non-bill sponsor amendment shall be determined as follows:

- 90 minutes divided by the total number of non-sponsor amendments filed.
- The time allocated for each non-bill sponsor amendment shall be divided equally between the open, questions, debate, and close.
- Amendments withdrawn prior to consideration of the bill don't count toward the total.

For the bills listed in Section C, time spent on debate shall be allocated as specified, with the time equally divided. In addition to the allotted time, the sponsor will explain and close the bill, closing not to exceed 10 minutes. After opening, the debate managers identified below (or their designee) shall be alternately recognized until their time runs out. Time not utilized is lost.

• Debate managers may speak in debate and yield time to other Members to debate; no Member may be recognized for debate unless a debate manager yields time to that Member. Recognitions of debate managers must go through the Speaker. A Member may not be recognized more than once in debate on the bill or amendment.
