**I. Consideration of the following bills:**

**CS/HB 241** by **Select Committee on Health Innovation, Massullo, Payne** (Similar CS/SB 56)

**Coverage for Skin Cancer Screenings;** Requires DMS to require contracted state group health insurance plans to provide coverage & payment for annual skin cancer screenings performed by specified persons without imposing any cost-sharing requirement; specifies requirement for & restriction on payments for such screenings. Effective Date: July 1, 2024

Select Committee on Health Innovation: Favorable With Committee Substitute; Appropriations Committee: Favorable; Health & Human Services Committee: Favorable

**CS/HB 1259** by **Select Committee on Health Innovation, Andrade, Stark** (Identical CS/SB 1612)

**Providers of Cardiovascular Services;** Requires AHCA to adopt rules that allow Level I Adult Cardiovascular Services program to use certain tools & treatments. Effective Date: July 1, 2024

Select Committee on Health Innovation: Favorable With Committee Substitute; Health & Human Services Committee: Favorable

**HB 7085** by **Health & Human Services Committee, Skidmore** (Compare CS/CS/SB 1582, SB 7070)

**Sickle Cell Disease;** Creates Sickle Cell Disease Research & Treatment Grant Program within DOH; specifies types of projects eligible for grant funding; revises sickle cell disease & sickle cell trait screening requirements; requires screening providers to notify newborn's parent or guardian, rather than newborn's primary care physician, of certain information; authorizes certain persons other than newborns who have been identified having sickle cell disease or carrying sickle cell trait to choose to be included in registry. Effective Date: upon becoming law

**CS/CS/HB 883** by **Health & Human Services Committee, Choice & Innovation Subcommittee, Koster, Basabe** (Identical CS/CS/SB 962)

**Short-acting Bronchodilator Use in Public and Private Schools;** Authorizes certain public & private school students to carry short-acting bronchodilators & components; provides school district, public school, private school, and parental requirements. Effective Date: July 1, 2024

Choice & Innovation Subcommittee: Favorable With Committee Substitute; PreK-12 Appropriations Subcommittee: Favorable; Health & Human Services Committee: Favorable With Committee Substitute

**CS/HB 1429** by **Education Quality Subcommittee, Bell, Valdés, López, J.** (Similar SB 1652)

**District and School Advisory Councils;** Renaming "district advisory councils" & "school advisory councils" as "district community advisory boards" & "community advisory boards"; & revises requirements for such boards. Effective Date: July 1, 2024

Education Quality Subcommittee: Favorable With Committee Substitute; Education & Employment Committee: Favorable

**CS/CS/HB 917** by **Education & Employment Committee, Choice & Innovation Subcommittee, Snyder, Bankson, Basabe, Roach, Salzman, Stark** (Similar CS/CS/SB 460, Compare HB 553)

**Career and Technical Education;** Revises duties of Office of Reimagining Education & Career Help; revises provisions relating to journeymen & specified career fairs; provides exemption for minors to work in specified conditions; revises list of individuals who are required to review & comment on certain revisions to state academic standards; requires DOE to convene workgroup by specified date; authorizes certain students to be exempt from completing certain examinations. Effective Date: July 1, 2024

Choice & Innovation Subcommittee: Favorable With Committee Substitute; Higher Education Appropriations Subcommittee: Favorable; Education & Employment Committee: Favorable With Committee Substitute

---

**CS/CS/HB 217 by Appropriations Committee, Postsecondary Education & Workforce Subcommittee, Mooney** (Similar CS/CS/SB 222)

**College Campus Facilities in Areas of Critical State Concern;** Revises authorized uses of revenue from capital improvement fees to include certain college campus facilities & revises number of beds certain FCS institutions may provide to certain persons; revises which funds may be used for construction of dormitories; & requires Division of Bond Finance to conduct analysis of financing before issuance of specified bonds. Effective Date: July 1, 2024

Postsecondary Education & Workforce Subcommittee: Favorable With Committee Substitute; Appropriations Committee: Favorable With Committee Substitute

---

**CS/HB 707 by Higher Education Appropriations Subcommittee, Silvers** (Identical CS/SB 1128)

**State University Unexpended Funds;** Authorizes state university to retain & report annual reserve balance exceeding specified amount; & authorizes state university's carry forward spending plan to include reserve fund to be used for authorized expenses in subsequent years. Effective Date: July 1, 2024

Higher Education Appropriations Subcommittee: Favorable With Committee Substitute; Postsecondary Education & Workforce Subcommittee: Favorable; Appropriations Committee: Favorable

---

**CS/HB 7025 by Education & Employment Committee, Education Quality Subcommittee, Trabulsy, Massullo, Valdés** (Similar SB 1444, Compare CS/CS/HB 1285, CS/CS/HB 1403, CS/HB 1425, CS/CS/CS/SB 996, CS/SB 1352, CS/SB 7004, SB 7048)

**Education;** Revises provisions relating to SBE, FCS, Academically Challenging Curriculum to Enhance Learning options, single-gender programs, charter technical career centers & public technical centers, virtual education options, school readiness program providers, VPK, & ELCs, Competency-Based Education Pilot Program, Art in Capitol Competition, DJJ education programs, automotive service technology education programs, Board of Trustees of St. Petersburg College, coordinated screening & progress monitoring system, & instructional materials adoption cycles. Effective Date: July 1, 2024

**CS/SB 7004 by Fiscal Policy, Education Pre-K -12, Osgood** (Compare CS/CS/HB 1285, CS/HB 7025, CS/CS/CS/SB 996, SB 1444)

**Deregulation of Public Schools/Assessment and Accountability, Instruction, and Education Choice;** Revising how often a school district or charter school must update its school capacity determination; deleting a requirement for the Commissioner of Education to provide for an annual comparative evaluation of charter technical career centers and public technical centers; deleting a requirement regarding assessment procedures for Department of Juvenile Justice education programs; providing additional options for a school that completes a plan cycle but does not meet certain requirements; deleting a requirement for the Commissioner of Education to review specified feedback reports and submit findings to the State Board of Education, etc. Effective Date: Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2024

**Education;** Revises requirements relating to district school board duties & responsibilities, requirements for student management of specified health conditions, prekindergarten instructors postsecondary educator preparation in field experiences, Florida Institute for Charter School Innovation, critical teacher shortages, collective bargaining, Teacher Apprenticeship Program, Dale Hickam Excellent Teaching Program, FCS institution employment equity accountability program, rent or lease of K-12 plants & facilities. Effective Date: July 1, 2024

**CS/SB 7002 by Fiscal Policy, Education Pre-K -12, Hutson, Osgood** (Compare CS/HB 109, CS/HB 1045, CS/HB 7039, CS/CS/SB 994)

**Deregulation of Public Schools/School District Finance and Budgets, Facilities, and Administration and Oversight;** Providing that district school boards are not subject to certain rule requirements under certain circumstances; requiring a district school board to advertise its intent to adopt a tentative budget on a publicly available website if it does not advertise such intent in a newspaper of general circulation; requiring district school boards to provide personnel access to facilities for emergency management, rather than staffing such facilities, or perform other specified duties as may be required in the county emergency management plan; revising requirements for signage that must be posted on certain school buses; requiring the Department of Education to annually inform district school superintendents that they may petition to receive a specified declaratory statement, etc. Effective Date: 07/01/2024

**CS/HB 85 by Insurance & Banking Subcommittee, Barnaby** (Similar CS/SB 1014)

**Pub. Rec./New State Banks and New State Trust Companies;** Provides exemption from public records requirements for information received by OFR relating to application for authority to organize new state bank or new state trust company until specified conditions are met; provides for future legislative review & repeal of exemptions; provides statement of public necessity. Effective Date: July 1, 2024

Insurance & Banking Subcommittee: Favorable With Committee Substitute; Ethics, Elections & Open Government Subcommittee: Favorable; Commerce Committee: Favorable

---

**CS/HB 293 by Regulatory Reform & Economic Development Subcommittee, Sirois, Daniels, Porras** (Similar CS/SB 600)

**Hurricane Protections for Homeowners' Associations;** Requires board or committee of homeowners' association to adopt hurricane protection specifications; requires such specifications conform to applicable building codes; prohibits board or committee of association from denying application for installation, enhancement, or replacement of certain hurricane protection; authorizes requirement to adhere to certain guidelines regarding external appearance of structure or improvement on parcel. Effective Date: upon becoming a law

---

**CS/HB 479 by Commerce Committee, Robinson, W., Steele, Valdés** (Similar SB 688)

**Alternative Mobility Funding Systems;** Authorizes local governments to adopt alternative mobility plan & fee system; provides requirements for application of adopted alternative system; prohibits alternative system from imposing responsibility for funding existing transportation deficiency upon new development; prohibits local governments that do not issue building permits from charging for transportation impacts associated with development; requires local governments that issue building permits to collect for extrajurisdictional impacts; prohibits local governments from assessing multiple charges for same transportation impact; revises requirements for calculation of impact fees by local governments & special districts. Effective Date: July 1, 2024

**CS/CS/HB 1273 by Commerce Committee, Regulatory Reform & Economic Development Subcommittee, Plasencia, Alvarez, Barnaby** (Similar SB 1600, Compare HB 1381, CS/CS/HB 1549)

**Reciprocity or Endorsement of Licensure;** Provides requirements for applicable board or DBPR relating to licensure by reciprocity & by endorsement; requires respective boards of occupations or DBPR to allow licensure by endorsement if applicant meets certain criteria; requires applicable health care regulatory boards or DOH to issue license or certificate to applicants who meet specified conditions; revises licensure by endorsement requirements for practice of acupuncture, medicine, professional or practical nursing, certified nursing assistants, pharmacy, midwifery, speech-language pathology & audiology, nursing home administration, dietetics & nutrition, electrology, massage therapy, opticianry, physical therapy, physical therapist assistantship, psychology & school psychology, & clinical social work, marriage & family therapy, & mental health counseling. Effective Date: July 1, 2024

**CS/HB 1245 by Regulatory Reform & Economic Development Subcommittee, Killebrew, Arrington, LaMarca, Silvers, Valdés** (Identical SB 1038)

**Veterinary Professional Associates;** Authorizes certain individuals to use title "veterinary professional associate"; authorizes such associates to perform certain duties & actions; prohibits such associates from prescribing certain drugs or controlled substances or performing surgical procedures; provides exceptions; provides that veterinarians are liable for acts or omissions of veterinary professional associates under their supervision & control. Effective Date: July 1, 2024

**CS/CS/HB 1465 by Commerce Committee, Insurance & Banking Subcommittee, Tuck, Daniels** (Similar CS/SB 1338)

**Pet Insurance and Wellness Programs;** Revises definition of term "property insurance" to include pet insurance; requires pet insurers to make certain disclosures to pet insurance applicants & policyholders; authorizes pet insurers to issue policies that exclude coverage on basis of preexisting conditions; provides pet insurer has specified burden of proof with regard to exclusions; requires pet insurers who issue policy that imposes waiting period to include provision allowing for waiver of waiting period upon completion of medical examination of covered pet by veterinarian. Effective Date: January 1, 2025

**HB 59 by Arrington, Eskamani, López, J., Tant** (Identical SB 50)

**Provision Of Homeowners' Association Rules and Covenants;** Requires association to provide copies of association's rules & covenants to every member before specified date, & every new member thereafter; requires association to provide members with copy of updated rules & covenants; authorizes association to adopt rules relating to standards & manner in which such copies are distributed; authorizes association to post complete copy of association's rules & covenants, or direct link thereto, on homepage of association's website; requires association to provide specified notice to its members. Effective Date: July 1, 2024

**CS/HB 133 by Commerce Committee, Chambliss, Plakon, Hunschofsky, Mooney, Tramont** (Similar SB 42)

**Criminal History of Licensees and Employees;** Provides period of time when convictions, or any other adjudication, for crimes may not be grounds for denial of licensure as barber or cosmetologist; providing exception; requires applicable board to approve certain educational program credits; repeals provision prohibiting employment of certain individuals by licensed vendor. Effective Date: July 1, 2024

**CS/CS/HB 1235 by Judiciary Committee, Criminal Justice Subcommittee, Baker** (Identical CS/SB 1230)

**Sexual Offenders and Sexual Predators;** Revises reporting requirements; specifies criteria applicable for removal of status for certain persons; revises registration requirements; revises provisions relating to verification; revises penalties. Effective Date: October 1, 2024

Criminal Justice Subcommittee: Favorable With Committee Substitute; Judiciary Committee: Favorable With Committee Substitute

---

**CS/CS/HB 1171 by Judiciary Committee, Criminal Justice Subcommittee, Steele** (Similar SB 1220)

**Schemes to Defraud;** Provides for reclassification of certain offenses when committed against persons 65 years of age or older, against minors, or against persons with disabilities; provides for civil actions for damages by persons whose image or likeness was used in scheme to defraud with their consent. Effective Date: October 1, 2024

Criminal Justice Subcommittee: Favorable With Committee Substitute; Justice Appropriations Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

---

**CS/HB 923 by Civil Justice Subcommittee, Fabricio** (Similar CS/SB 1064)

**Wills and Estates;** Revising provisions related to probate records & Florida Uniform Disposition of Community Property Rights at Death Act. Effective Date: upon becoming a law

Civil Justice Subcommittee: Favorable With Committee Substitute; Judiciary Committee: Favorable

---

**CS/CS/HB 1001 by Appropriations Committee, Ways & Means Committee, Stevenson** (Similar CS/SB 1030)

**Taxation;** Removes registration fee for certain parties; specifies application of exemption for sales taxes for purchasers of boats & aircrafts; specifies certain purchases are considered single item; authorizes parties to include additional specified amounts in garnishment levy notice; revises methods for delivery of levy notices; revises amount of tax that must be paid to be considered compliant with specified statute. Effective Date: July 1, 2024

Ways & Means Committee: Favorable With Committee Substitute; Appropriations Committee: Favorable With Committee Substitute

---

**CS/HB 1093 by Judiciary Committee, Caruso** (Similar CS/CS/SB 1316)

**Florida Uniform Fiduciary Income and Principal Act;** Revises provisions of Florida Uniform Principal & Income Act governing trusts, estates, life estates, & other term interests. Effective Date: January 1, 2025

Civil Justice Subcommittee: Favorable; Insurance & Banking Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

---

**HB 1367 by Brackett, Barnaby** (Similar CS/SB 720)

**Asbestos and Silica Claims;** Revises information required to be included in sworn information form for asbestos or silica claims; specifies such form is inadmissible in evidence at trial; requires courts to dismiss certain claims upon motion by defendant; requires motions to dismiss to include certain certifications. Effective Date: July 1, 2024

Civil Justice Subcommittee: Favorable; Judiciary Committee: Favorable

---

**HB 1393 by Tuck** (Identical SB 468)

**Court Interpreter Services;** Authorizes state courts system to use state revenues, if available, to provide court-appointed interpreting services to nonindigent individuals; requires such services to be provided as prescribed by Supreme Court; removes cost recovery requirement for court-appointed interpreting services; provides exception for translation services. Effective Date: upon becoming a law

Civil Justice Subcommittee: Favorable; Justice Appropriations Subcommittee: Favorable; Judiciary Committee: Favorable

**CS/HB 1415 by Civil Justice Subcommittee, Chamberlin** (Similar SB 1712)

**Peer Support for First Responders;** Revises definition of "first responder" to include correctional officers & correctional probation officers. Effective Date: October 1, 2024

Civil Justice Subcommittee: Favorable With Committee Substitute; Judiciary Committee: Favorable

---

**CS/HB 1425 by Judiciary Committee, Yarkosky** (Similar CS/SB 1352, Compare CS/HB 7025)

**Juvenile Justice;** Authorizes DJJ employees & contracted providers to possess & administer opioid antagonists; provides immunity from liability for administration; replacing term "gender-specific" with "sex-specific"; eliminates minimum-risk nonresidential restrictiveness level; redesignates "nonsecure residential restrictiveness level" as "moderate-risk residential level"; revises provisions concerning transitioning child to & from secure detention care & supervised release detention care. Effective Date: July 1, 2024

Criminal Justice Subcommittee: Favorable; Justice Appropriations Subcommittee: Favorable; Judiciary Committee: Favorable With Committee Substitute

---

**CS/CS/HB 45 by Justice Appropriations Subcommittee, Civil Justice Subcommittee, Gottlieb, Koster, Arrington, Tant** (Similar CS/CS/CS/SB 86)

**Hope Cards for Persons Issued Orders of Protection;** Requires clerks of circuit court, in consultation with Office of Attorney General, to develop & implement Hope Card Program; requires clerks to implement program; authorizes persons to request Hope Card after specified date; specifies when & how person may request Hope Card; requires clerks' offices to create Hope Card & provide such card to petitioners within specified time frame; prohibits assessment of fee; provides requirements for Hope Card; provides criminal penalties for fraudulent use of Hope Card. Effective Date: October 1, 2024

---

**CS/HB 6007** by Civil Justice Subcommittee, Yarkosky, Daniels, Garcia (Identical CS/SB 10)

**Relief/Julia Perez/St. Johns County Sheriff's Office;** Provides for relief of Julia Perez by the St. Johns County Sheriff's Office; provides for appropriation of funds to compensate Julia Perez for personal injuries & damages sustained as result of negligence of employee of St. Johns County Sheriff's Office; provides legislative intent for waiver of certain lien interests; provides limitation on compensation & payment of attorney fees. Effective Date: upon becoming a law

---

**CS/CS/HB 1389** by Judiciary Committee, Criminal Justice Subcommittee, Cassel, Cross, Garcia, Lopez, V. (Identical CS/CS/SB 1604)

**Digital Voyeurism;** Redesignates "video voyeurism" as "digital voyeurism"; revises elements; provides reduced criminal penalties for certain violations by persons under 19 years of age; specifies that each instance of certain violations is separate offense; provides for reclassification of certain violations by certain persons who are family or household members of victim or who hold position of authority or trust with victim. Effective Date: October 1, 2024

Criminal Justice Subcommittee: Favorable With Committee Substitute; Judiciary Committee: Favorable With Committee Substitute

---

**HB 937** by Casello, Keen (Identical CS/SB 640)

**B. PROCEDURES:**

Time allocations apply to all bills listed in Section A and any bill substituted for or taken up in lieu of a listed bill. Amendment sponsors shall have 2 minutes to open and 2 minutes to close, except as outlined below.

Except for the bills listed in Section C, the House shall spend no more than the following times:

- For each bill:
  - Questions and answers - 10 minutes
  - Debate - 5 minutes
- For each amendment:
  - Questions and answers - 5 minutes
  - Debate - 5 minutes

For all bills, along with their associated amendments, the time for questions and answers includes both the question and the answer and shall be no more than the times listed. Neither the question nor the answer shall be protracted in an attempt to use up the time.

Once more than 10 non-bill sponsor amendments are filed, the allocation of time spent on each non-bill sponsor amendment shall be determined as follows:

- 90 minutes divided by the total number of non-sponsor amendments filed.
- The time allocated for each non-bill sponsor amendment shall be divided equally between the open, questions, debate, and close.
- Amendments withdrawn prior to consideration of the bill don't count toward the total.

For the bills listed in Section C, time spent on debate shall be allocated as specified, with the time equally divided. In addition to the allotted time, the sponsor will explain and close the bill, closing not to exceed 10 minutes. After opening, the debate managers identified below (or their designee) shall be alternately recognized until their time runs out. Time not utilized is lost.

- Debate managers may speak in debate and yield time to other Members to debate; no Member may be recognized for debate unless a debate manager yields time to that Member. Recognitions of debate managers must go through the Speaker. A Member may not be recognized more than once in debate on the bill or amendment.

**B. PROCEDURES:**

Time allocations apply to all bills listed in Section A and any bill substituted for or taken up in lieu of a listed bill. Amendment sponsors shall have 2 minutes to open and 2 minutes to close, except as outlined below.

Except for the bills listed in Section C, the House shall spend no more than the following times:

- For each bill:
  - Questions and answers - 10 minutes
  - Debate - 5 minutes
- For each amendment:
  - Questions and answers - 5 minutes
  - Debate - 5 minutes

For all bills, along with their associated amendments, the time for questions and answers includes both the question and the answer and shall be no more than the times listed. Neither the question nor the answer shall be protracted in an attempt to use up the time.

Once more than 10 non-bill sponsor amendments are filed, the allocation of time spent on each non-bill sponsor amendment shall be determined as follows:

- 90 minutes divided by the total number of non-sponsor amendments filed.
- The time allocated for each non-bill sponsor amendment shall be divided equally between the open, questions, debate, and close.
- Amendments withdrawn prior to consideration of the bill don't count toward the total.

For the bills listed in Section C, time spent on debate shall be allocated as specified, with the time equally divided. In addition to the allotted time, the sponsor will explain and close the bill, closing not to exceed 10 minutes. After opening, the debate managers identified below (or their designee) shall be alternately recognized until their time runs out. Time not utilized is lost.

- Debate managers may speak in debate and yield time to other Members to debate; no Member may be recognized for debate unless a debate manager yields time to that Member. Recognitions of debate managers must go through the Speaker. A Member may not be recognized more than once in debate on the bill or amendment.
