

**AMENDMENT # 2  
TO CONTRACT # JEA11216  
BETWEEN  
JEA  
AND  
GRAYROBINSON, P.A.**

**THIS AMENDMENT NUMBER 2 (“Second Amendment”)** is made and entered into this 23<sup>rd</sup> day of August, 2023, (the “Effective Date”), by and between **JEA**, a body politic and corporate located at 225 N. Pearl St., Jacksonville, Florida, 32202, and **GRAYROBINSON P.A.**, a Florida corporation authorized to perform work in the State of Florida, with a principal address of 301 E. Pine Street, Suite 1400, Orlando, Florida 32801, United States (the “Company”).

**RECITALS:**

**WHEREAS**, on **November 1, 2020**, the parties made and entered into an agreement (the “Original Agreement”) under which Company agreed to provide “**State Government Relations Consulting Services**” (the “Work”) to JEA pursuant to JEA Contract Number JEA11216 until **October 31, 2022** (the “Term”), with two (2), one (1) year renewal options, for a maximum indebtedness of **One Hundred Eighty Thousand and 00/100 Dollars (\$180,000.00)** (the “Maximum Indebtedness”); and

**WHEREAS**, on **August of 2022**, JEA determined it was in our best interest to expand the scope of work and add Federal Government Relations Consulting services to this contract. An administrative increase was completed on **September 14, 2022**, in the amount of **Six Thousand Two Hundred Seventy and 00/100 Dollars (\$6,270.00)** for a new Maximum Indebtedness of **One Hundred Eighty Six Thousand Two Hundred Seventy and 00/100 Dollars (\$186,270.00)**; and

**WHEREAS**, on **October 13, 2022**, JEA increased the Maximum Indebtedness in the amount **One Hundred Twenty-Six Thousand and 00/100 Dollars (\$126,000.00)**, as approved by the JEA Awards Committee on **October 13, 2022**, for a new Maximum Indebtedness of **Three Hundred Twelve Thousand Two Hundred Seventy and 00/100 Dollars (\$312,270.00)**, and extend the Term of the Original Agreement until **October 31, 2023**; and

**WHEREAS**, JEA now desires to increase the Maximum Indebtedness in the amount of **One Hundred Twenty Six Thousand and 00/100 Dollars (\$126,000.00)**, as allowed by the JEA Procurement Code, for a new Maximum Indebtedness of **Four Hundred Thirty Eight Thousand Two Hundred Seventy and 00/100 Dollars (\$438,270.00)**, and renew the Term of the Original Agreement until **October 22, 2024**.

**IN CONSIDERATION** of the Original Agreement and for the mutual promises and covenants herein contained, the sufficiency and receipt of which is hereby acknowledged, the parties agree as follows:

**AGREEMENT:**

1. **Maximum Indebtedness.** The Maximum Indebtedness of the Original Agreement shall be increased by **One Hundred Twenty Six Thousand and 00/100 Dollars (\$126,000.00)**, and shall be invoiced to JEA in accordance with the Original Agreement. The Maximum Indebtedness shall now be **Four Hundred Thirty Eight Thousand Two Hundred Seventy and 00/100 (\$438,270.00)**.

2. **Term.** The Term of the Original Agreement shall be renewed until **October 22, 2024**.

3. The above recitals are true and correct and, by reference, are incorporated herein and made part hereof.

**SAVE AND EXCEPT** as hereby specifically amended herein, the terms and conditions of the Original Agreement, as amended, shall remain in full force and effect.
