

AGREEMENT BETWEEN THE CEDAR HAMMOCK FIRE CONTROL DISTRICT AND
RAMBA LAW GROUP, LLC
FOR REPRESENTATION FOR 2019 LEGISLATIVE APPROPRIATIONS

This Agreement for services regarding Representation for 2019 Legislative Appropriations (hereinafter "Agreement") is entered into by and between the Cedar Hammock Fire Control District, a political subdivision of the State of Florida organized under Chapter 191, Florida Statutes (hereinafter the "District"), whose address is 5200 26th Street West, Bradenton, FL 34207, and Ramba Law Group, LLC, a Florida Limited Liability Company whose address is 120 South Monroe Street, Tallahassee, FL 32301 (hereinafter "Contractor"), as of the date appearing on the signature lines below.

ARTICLE 1 - WORK

This Agreement sets forth the general terms and conditions pursuant to which District retains Contractor to provide services regarding Representation for 2019 Legislative Appropriations on an as required basis for the District. The Scope of Services for this Agreement is described in detail in Exhibit "A" attached to this Agreement.

ARTICLE 2 - COMPENSATION

Compensation payable to Contractor for services rendered and expenditures incurred in providing the services identified in Exhibit "A" shall be established through a Purchase Order. The Purchase Order amount will be based on the Contractor's estimate for specific work assignments requested by the District. Compensation to Contractor shall be at the rate of \$225.00 per hour not to exceed the total amount of \$20,000.00. Payment for services will be billed monthly and capped at the maximum compensation authorized for each Purchase Order to provide services as defined in Exhibit "A."

ARTICLE 3 - INVOICES AND TIME OF PAYMENT

Contractor shall provide District with an invoice which shall include all compensation due Contractor as of the date of the invoice and in accordance with the following:

- A. Contractor shall provide District with invoices not more frequently than once a month for each calendar month in which services are provided. Special exceptions can be made for extenuating circumstances.
- B. Contractor's invoice shall be in a form acceptable to District, provide specific details with respect to actual service units and/or hours of work incurred, and include other such detail as may reasonably be requested by the District.
- C. Total compensation to Contractor for services shall not exceed the amounts specified in the Purchase Order.


ARTICLE 4 - PUBLIC RECORDS

Pursuant to applicable Florida law, Contractor's records associated with this Agreement may be subject to Florida's public record laws, Florida Statutes 119.01, *et seq*, as amended from time to time. Contractor shall comply with all public records obligations set forth in such laws, including those obligations to keep, maintain, provide access to, and maintain any applicable exemptions to public records, and transfer all such public records to the District at the conclusion of this Agreement, as provided for in Florida Statutes 119.0701.




